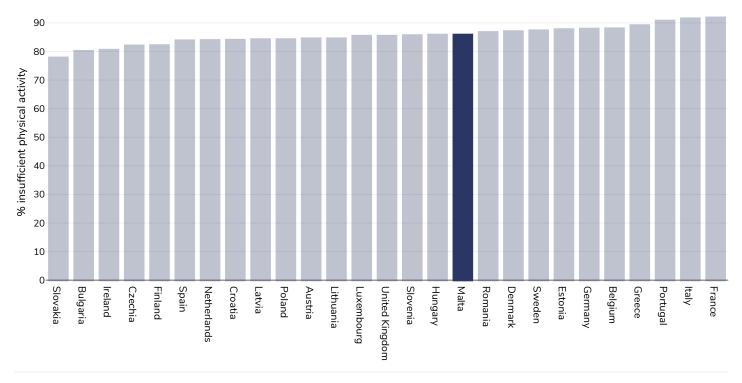

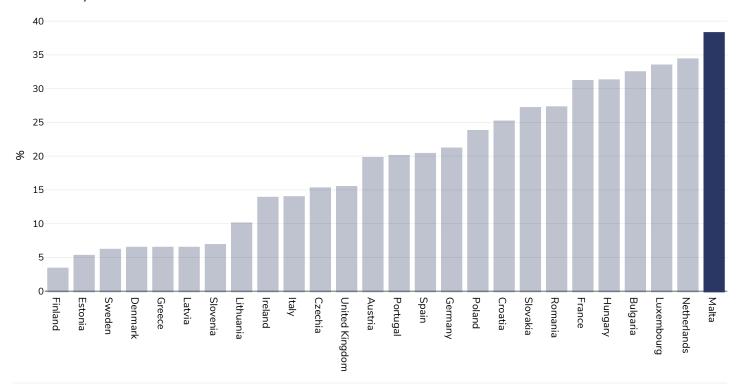

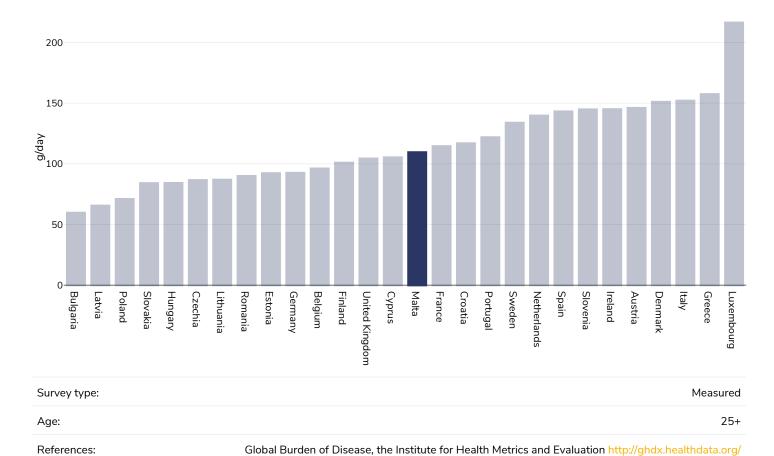

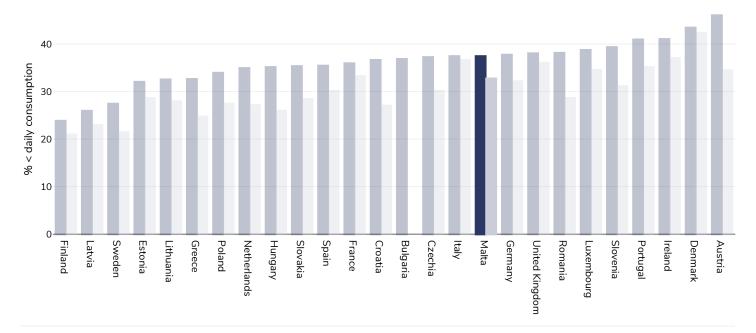
Estimated per-capita fruit intake (g/day)

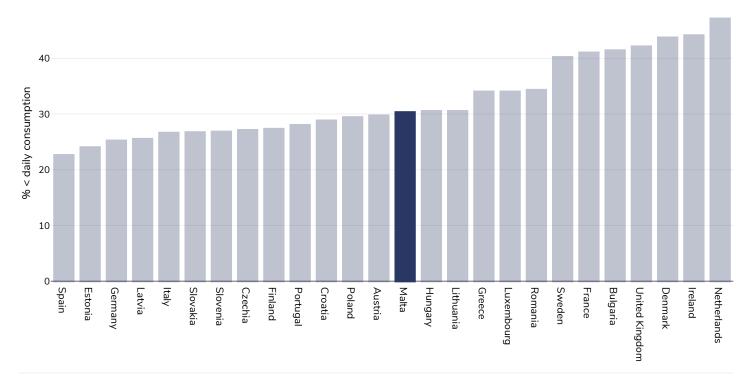

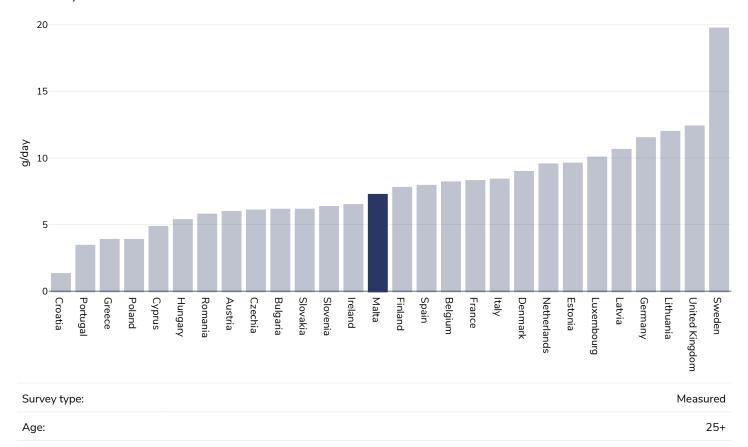


Estimated per-capita processed meat intake

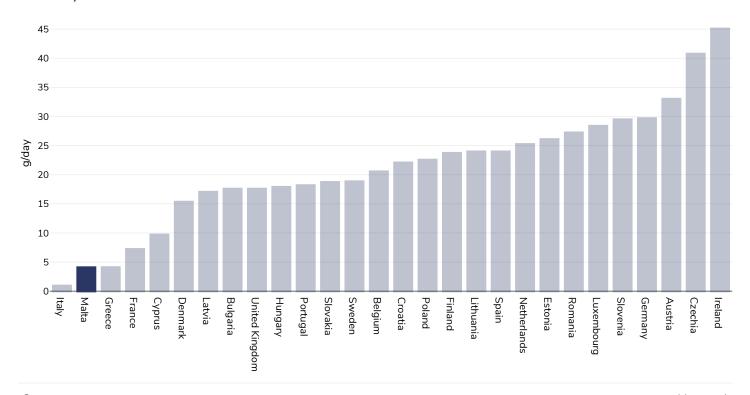

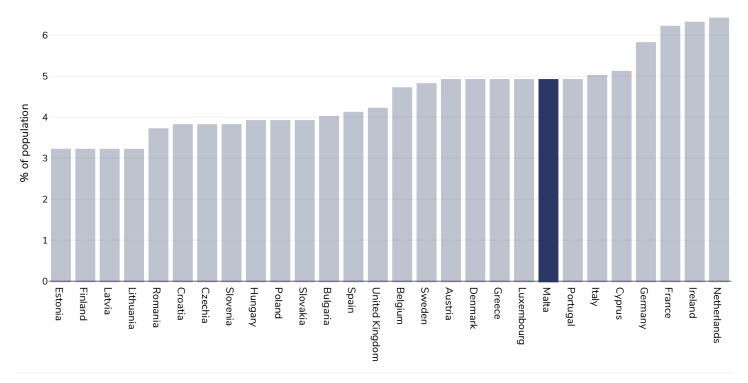

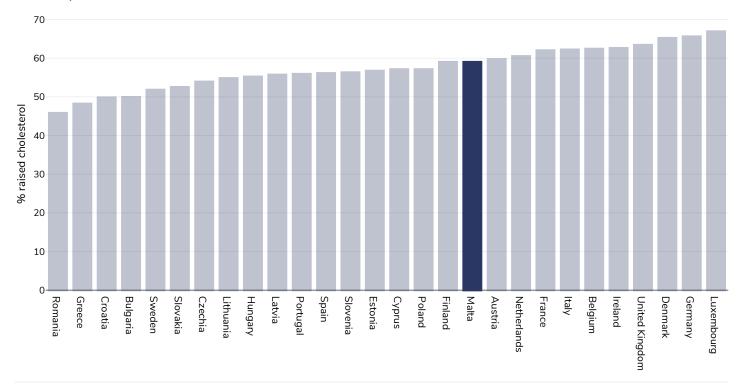
