


Notes: The data were extracted from the Register of Primary Health Care Visits (Avohilmo). The data are based on height and weight measurements taken during the visit.

Definitions: The definition of obesity is based on the body mass index. ISO-BMI (a body mass index corresponding to the adults' body mass index) describes a child whose weight index remains at the current level in comparison with the child's peers. Child and adolescent with obesity is defined as having an ISO-BMI of 30 kg/m² or higher. Child and adolescent with overweight (incl. obesity) is defined as having an ISO-BMI of 25 kg/m² or higher.


























