






Combined prevalence of BMI<18.5 kg/m 2 and BMI>=30 kg/m 2 (double burden of underweight and obesity)



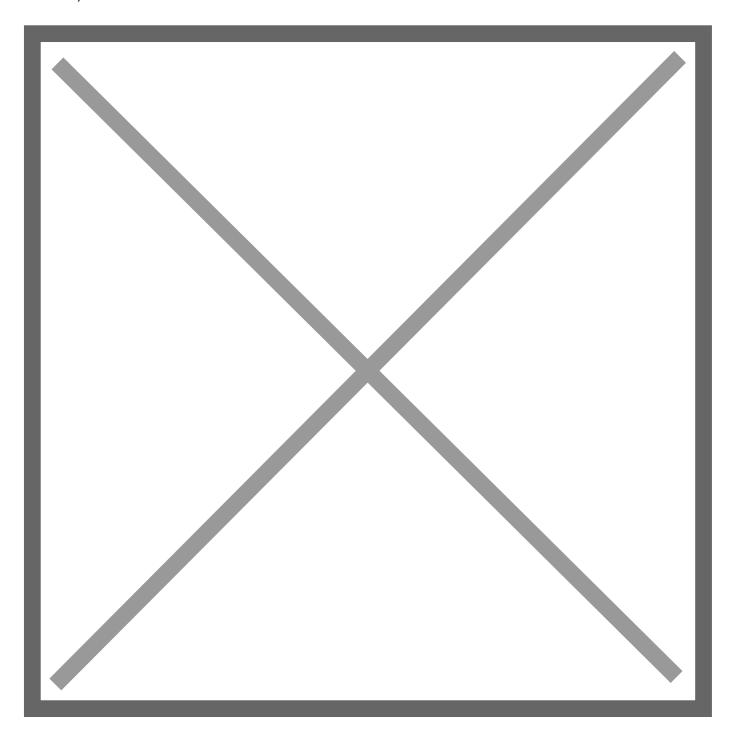






Liver and intrahepatic bile duct Cancer
