







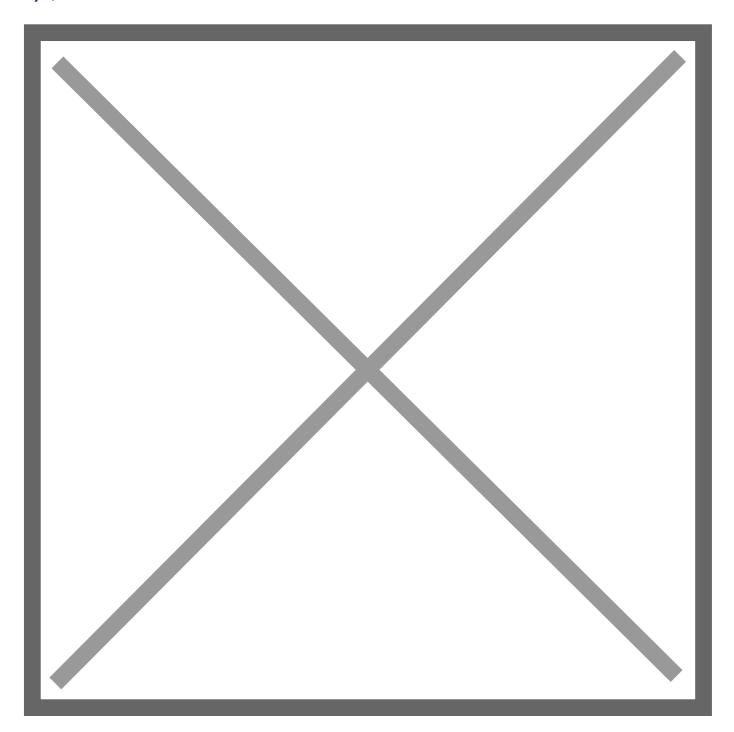




Prevalence of less than daily fruit consumption



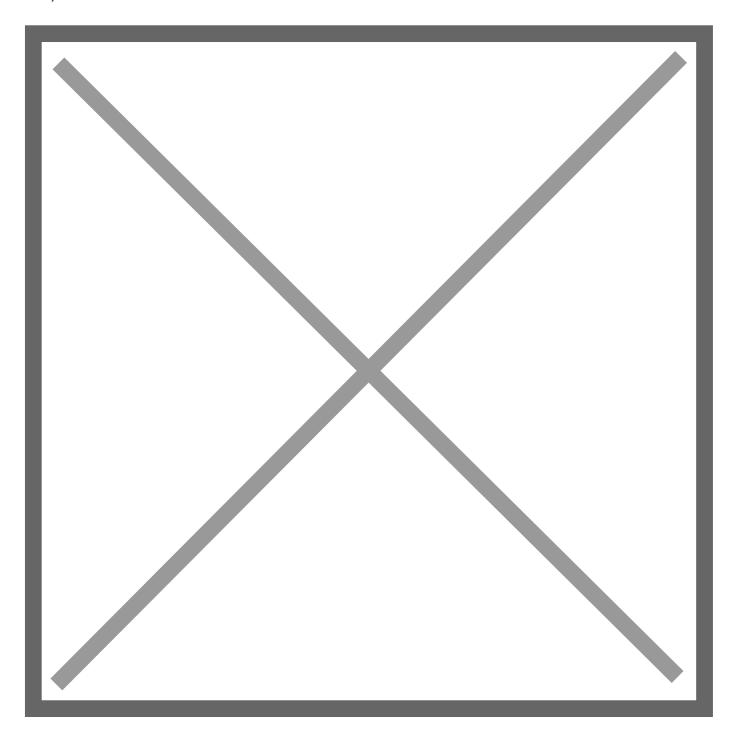

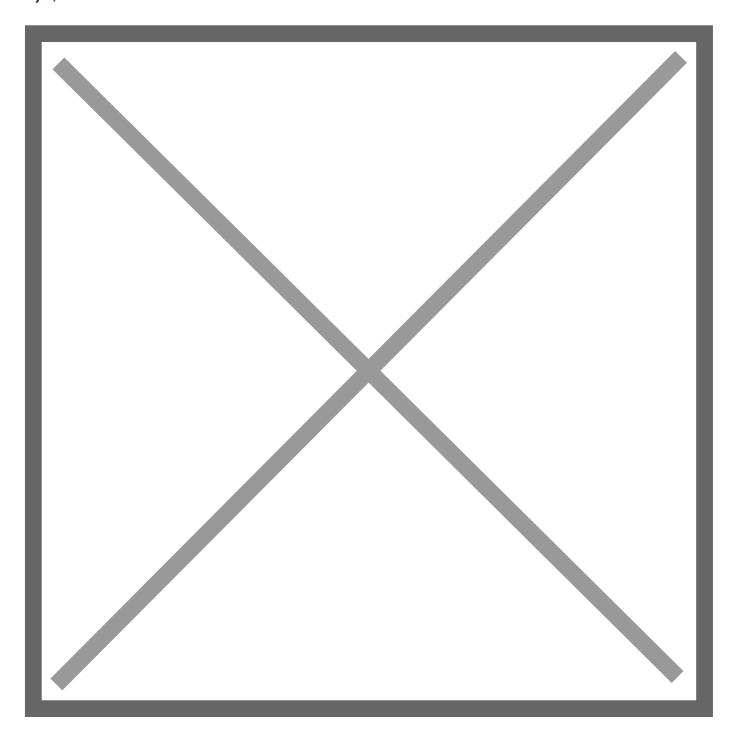

Prevalence of less than daily vegetable consumption







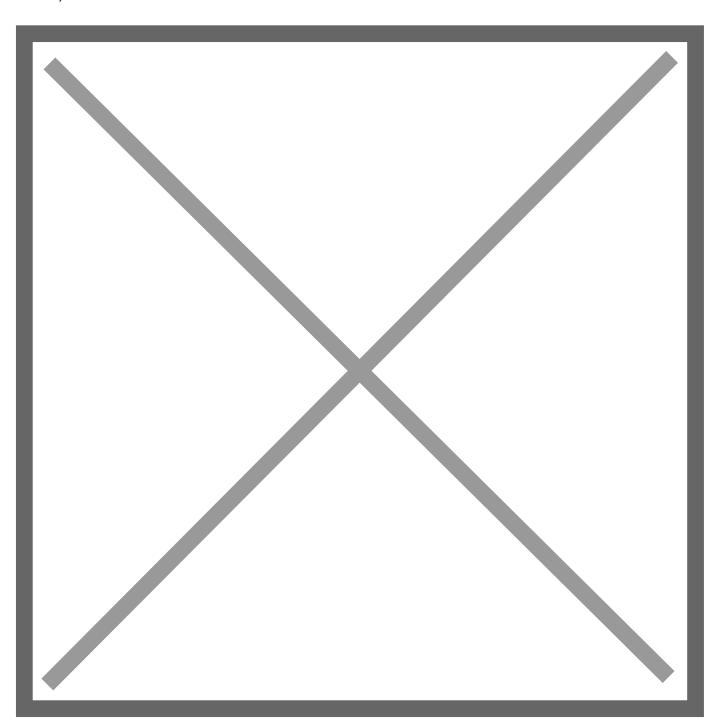



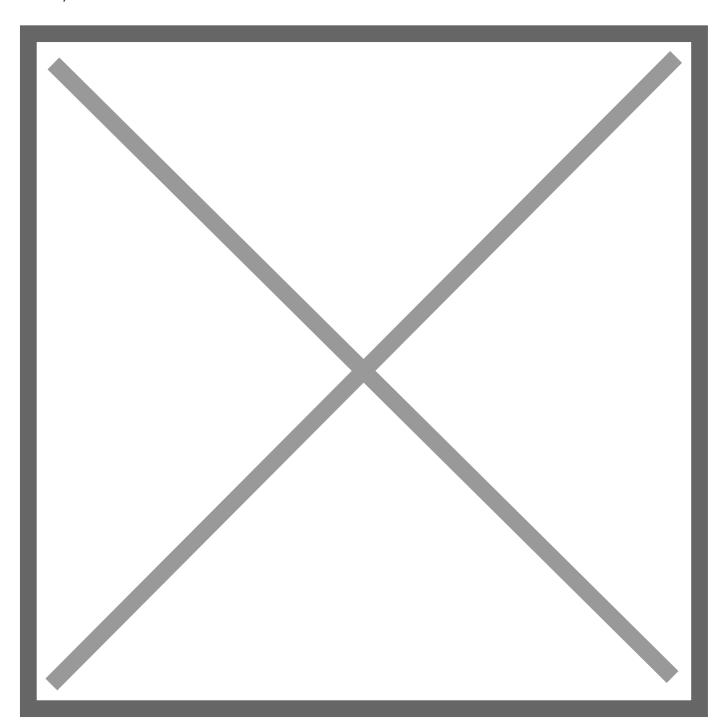











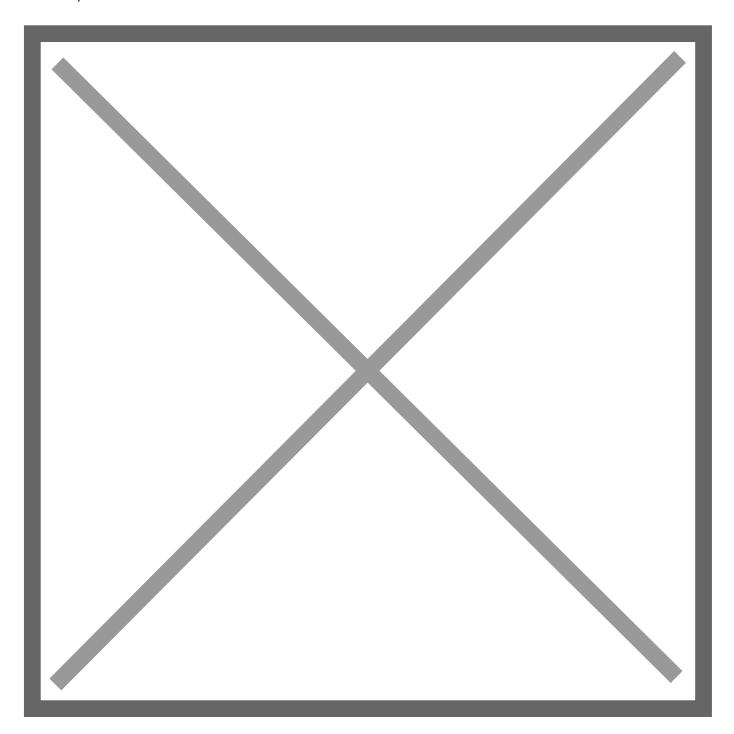
