




## % Adults living with obesity in Maldives 2009-2016



## Average daily frequency of carbonated soft drink consumption







## Average weekly frequency of fast food consumption




# % Infants exclusively breastfed 0-5 months

# Percent of population who cannot afford a healthy diet















# Raised fasting blood glucose
