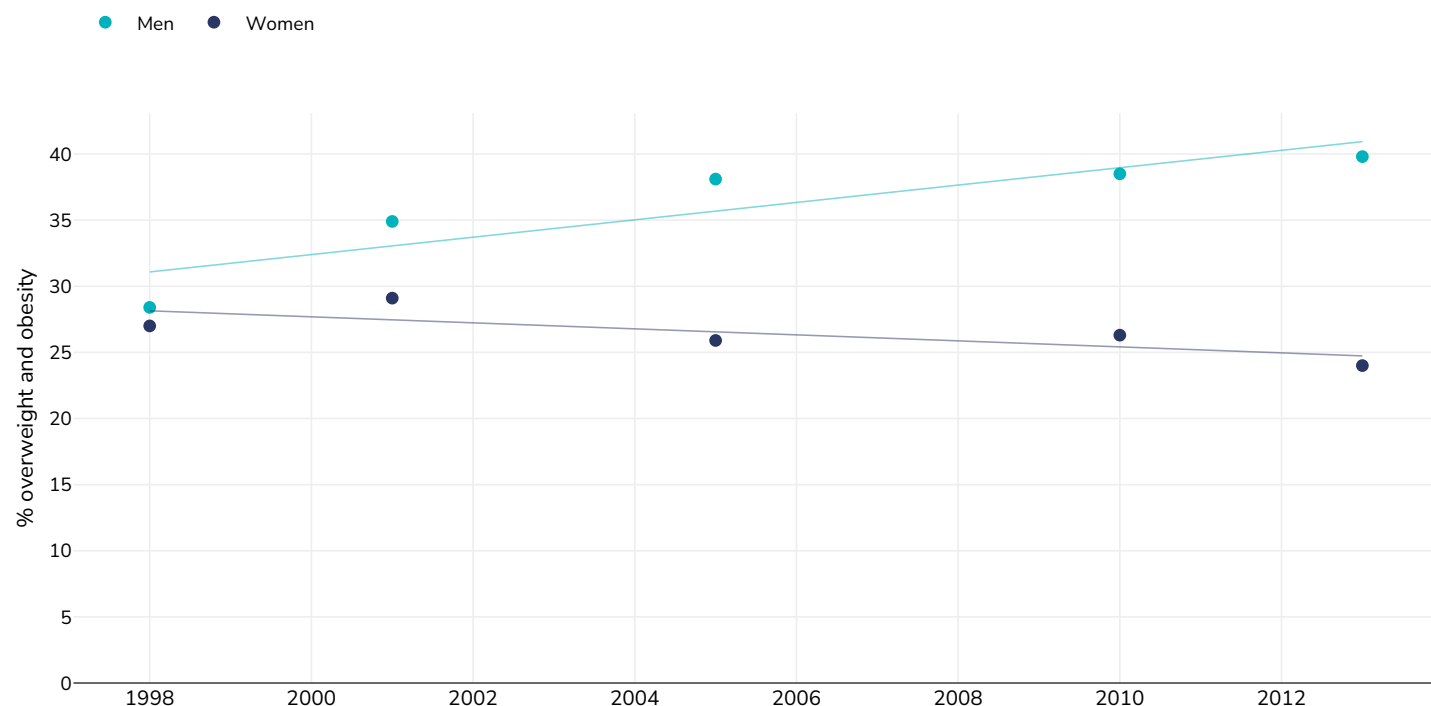

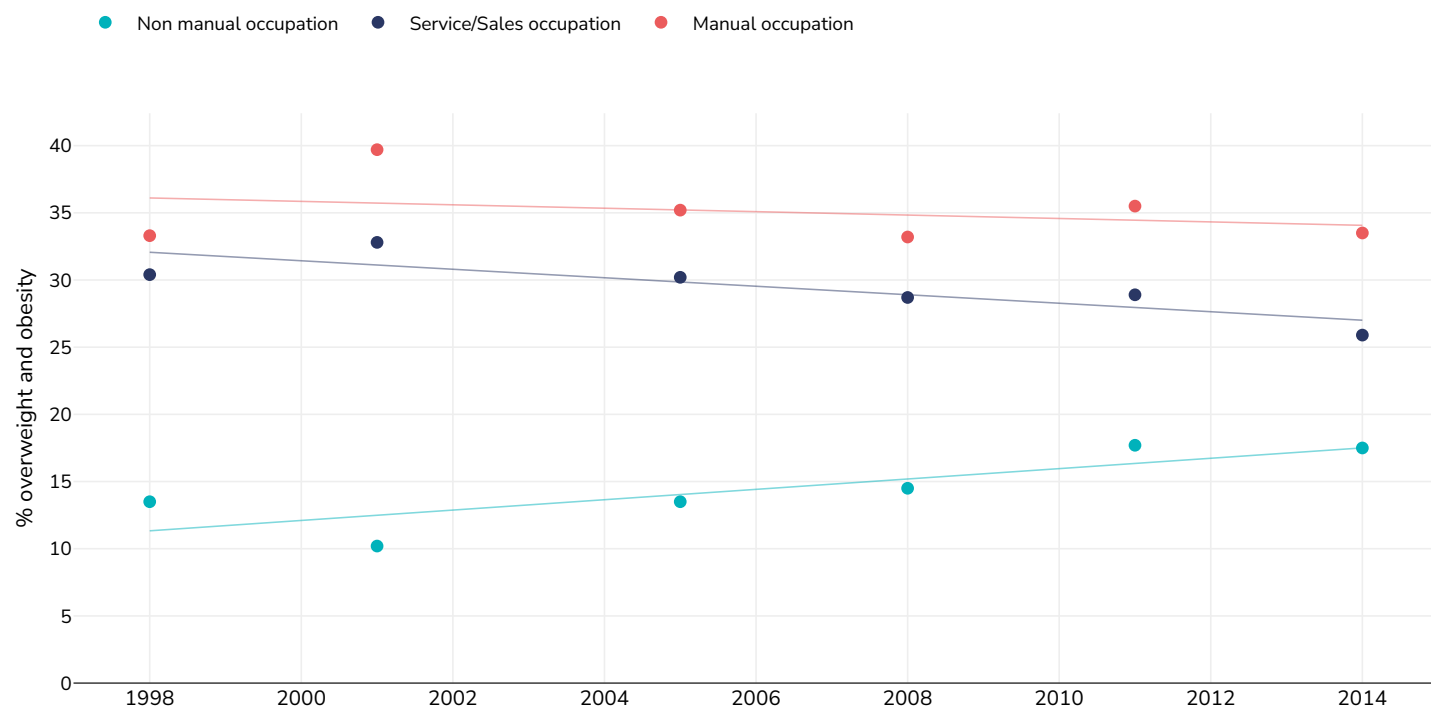

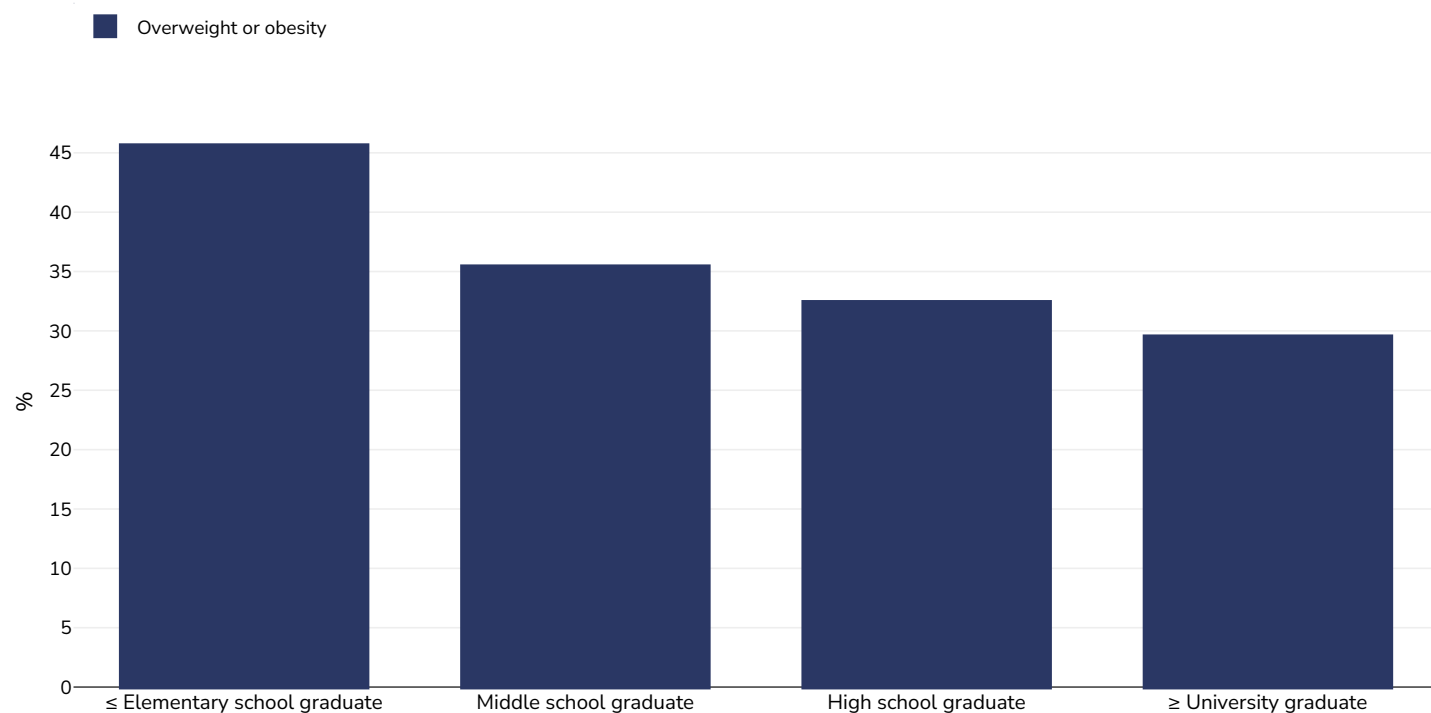

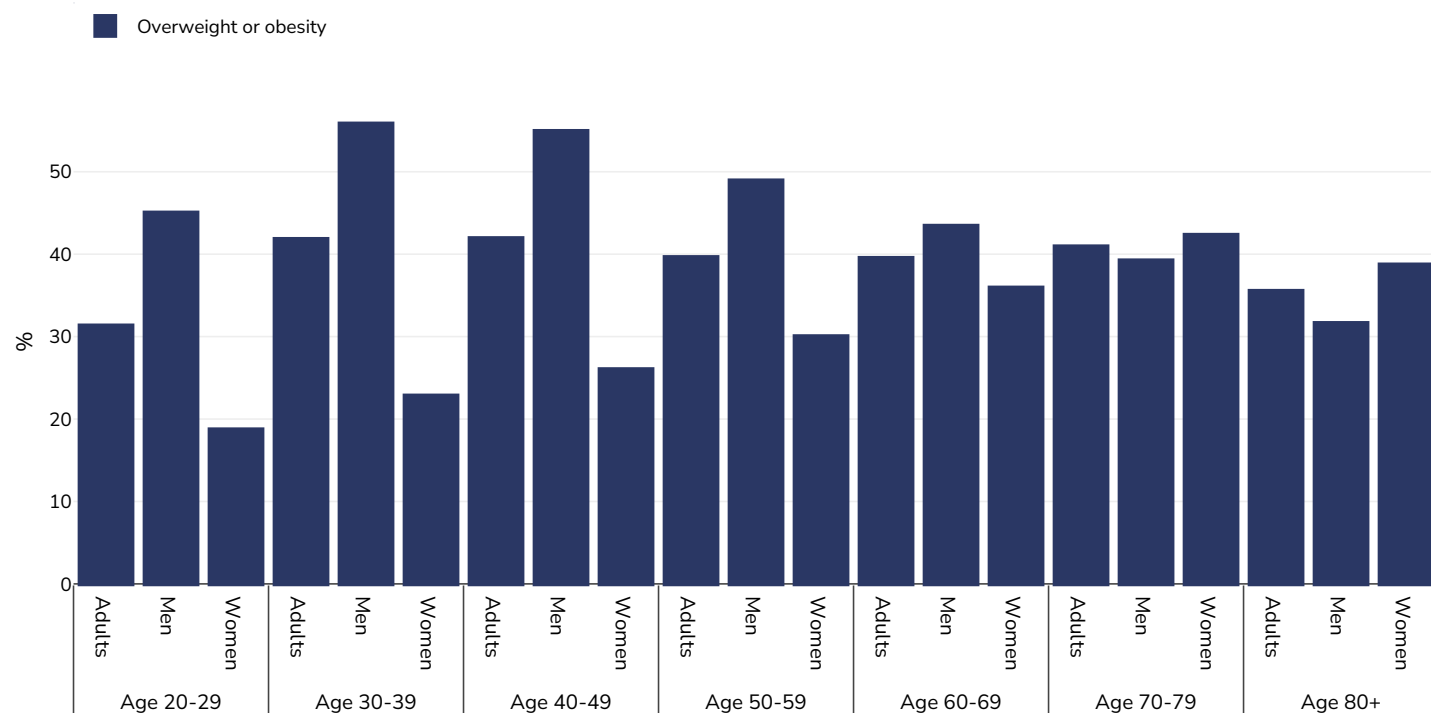

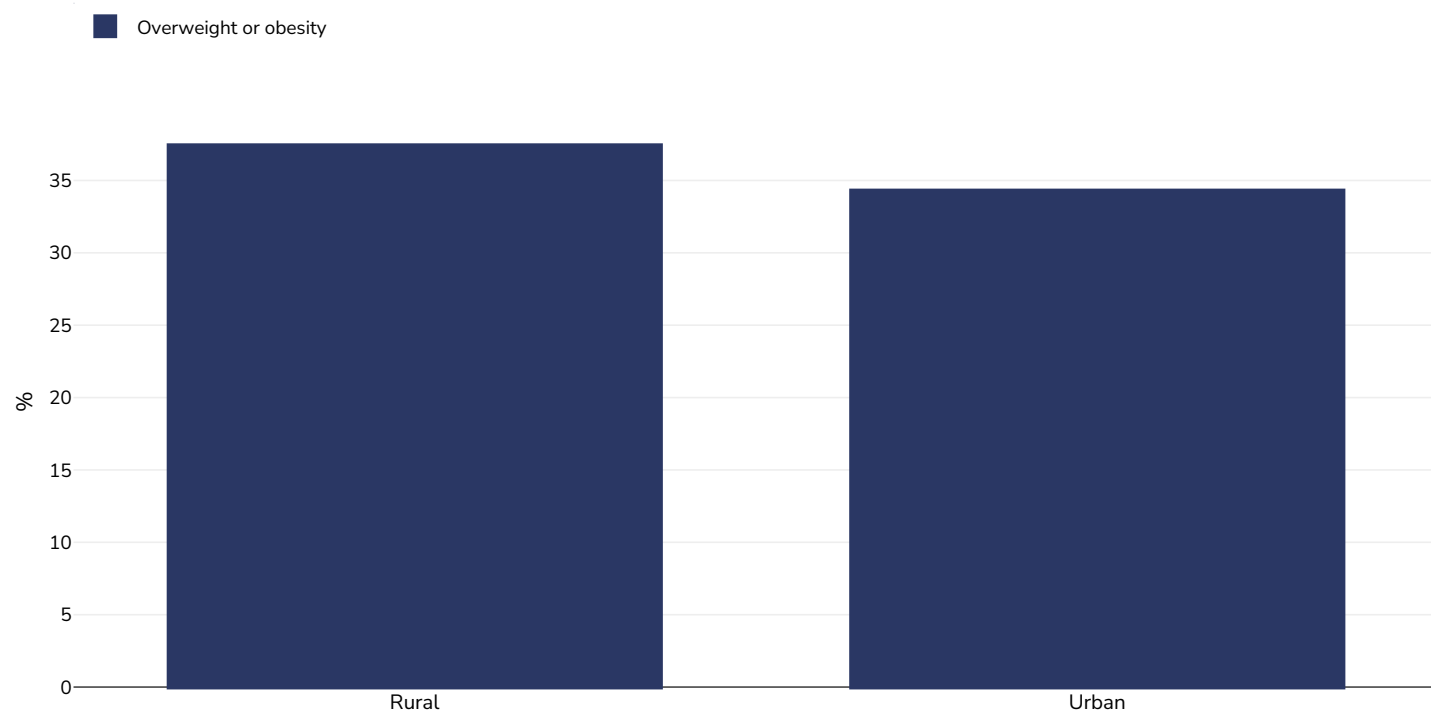

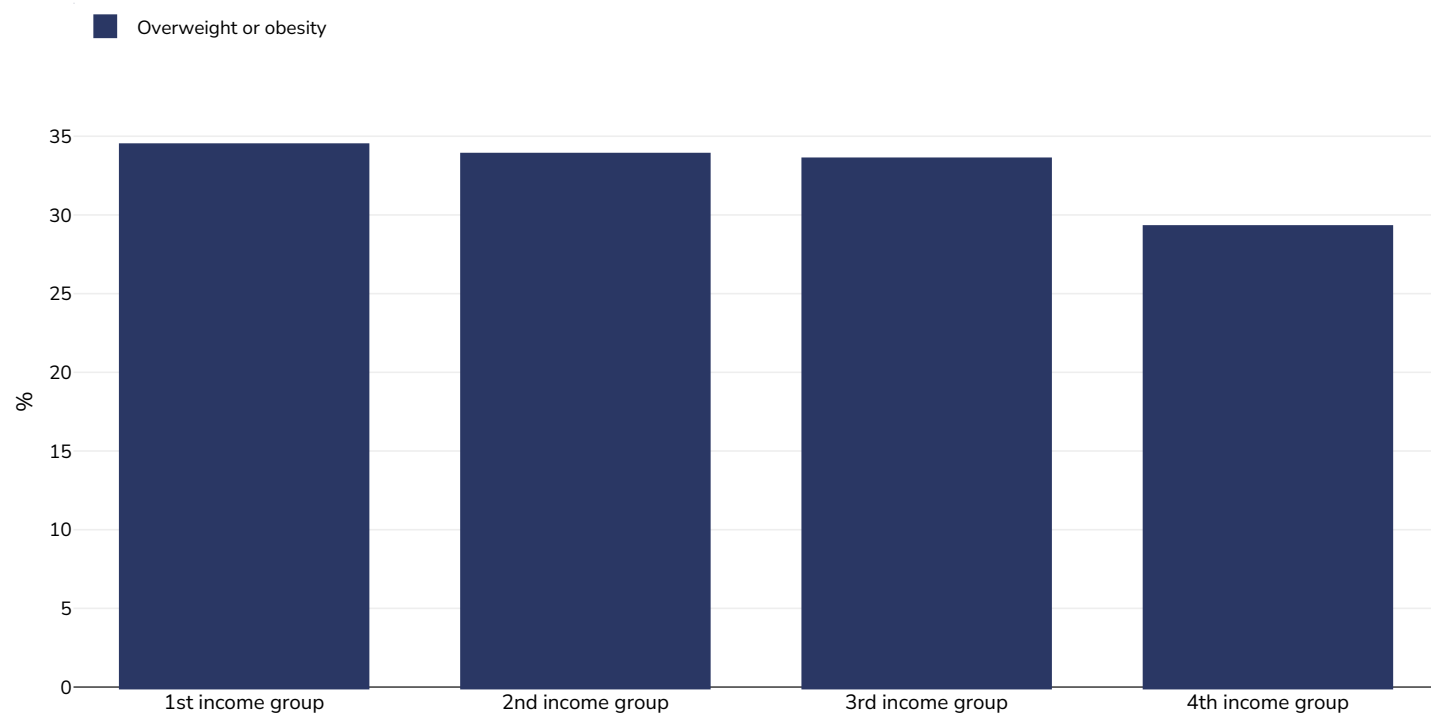

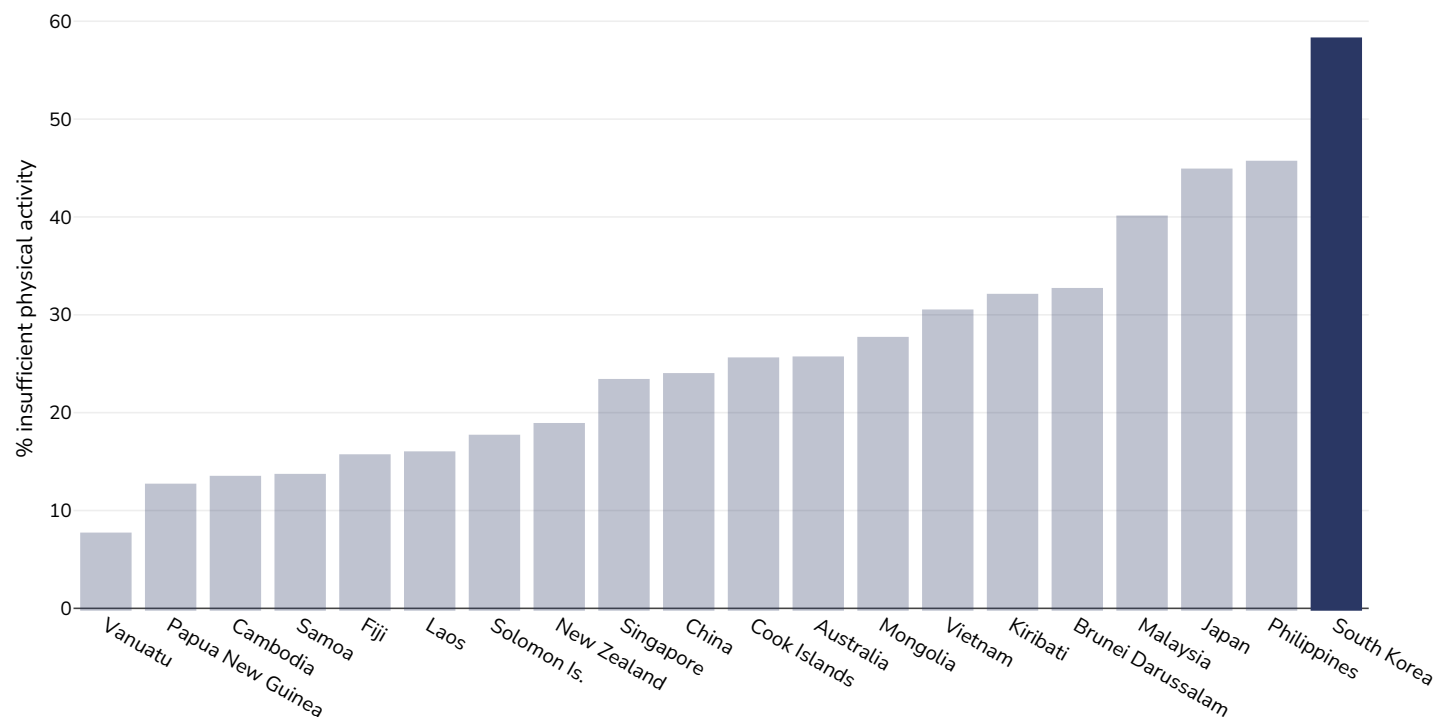

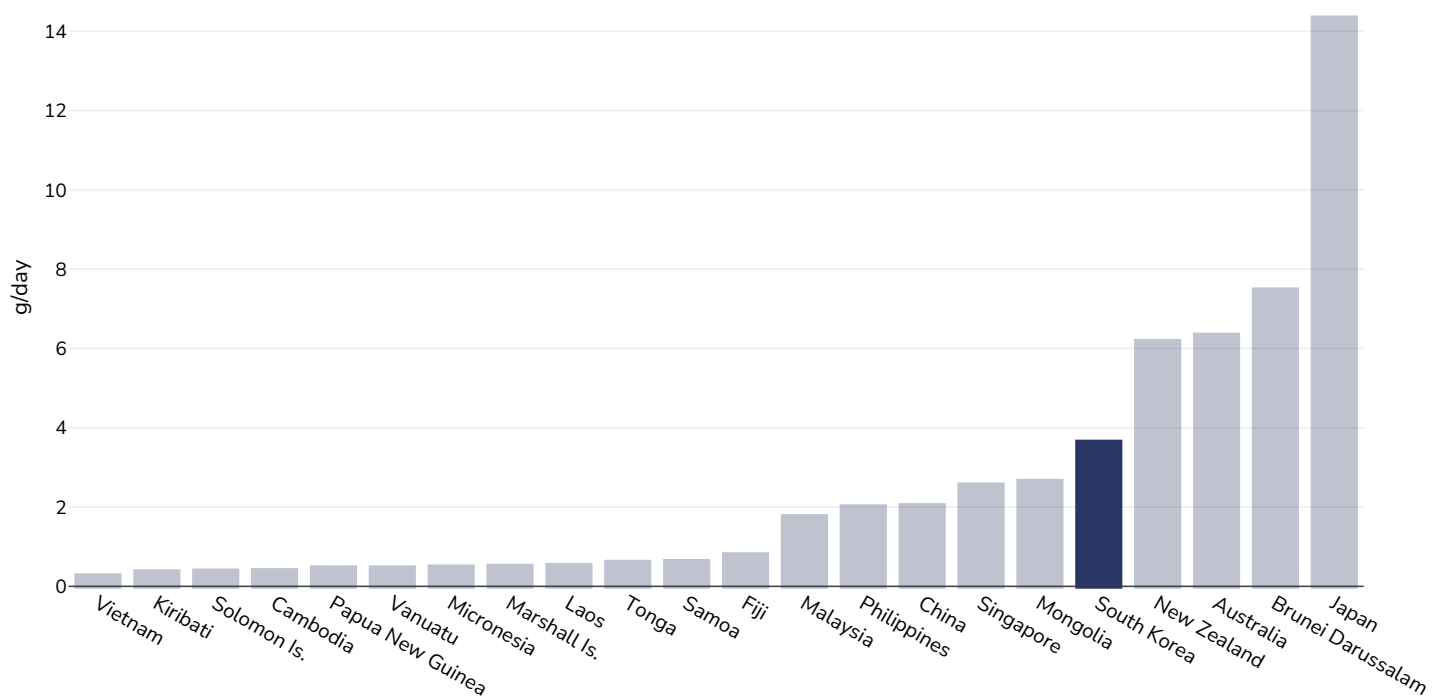

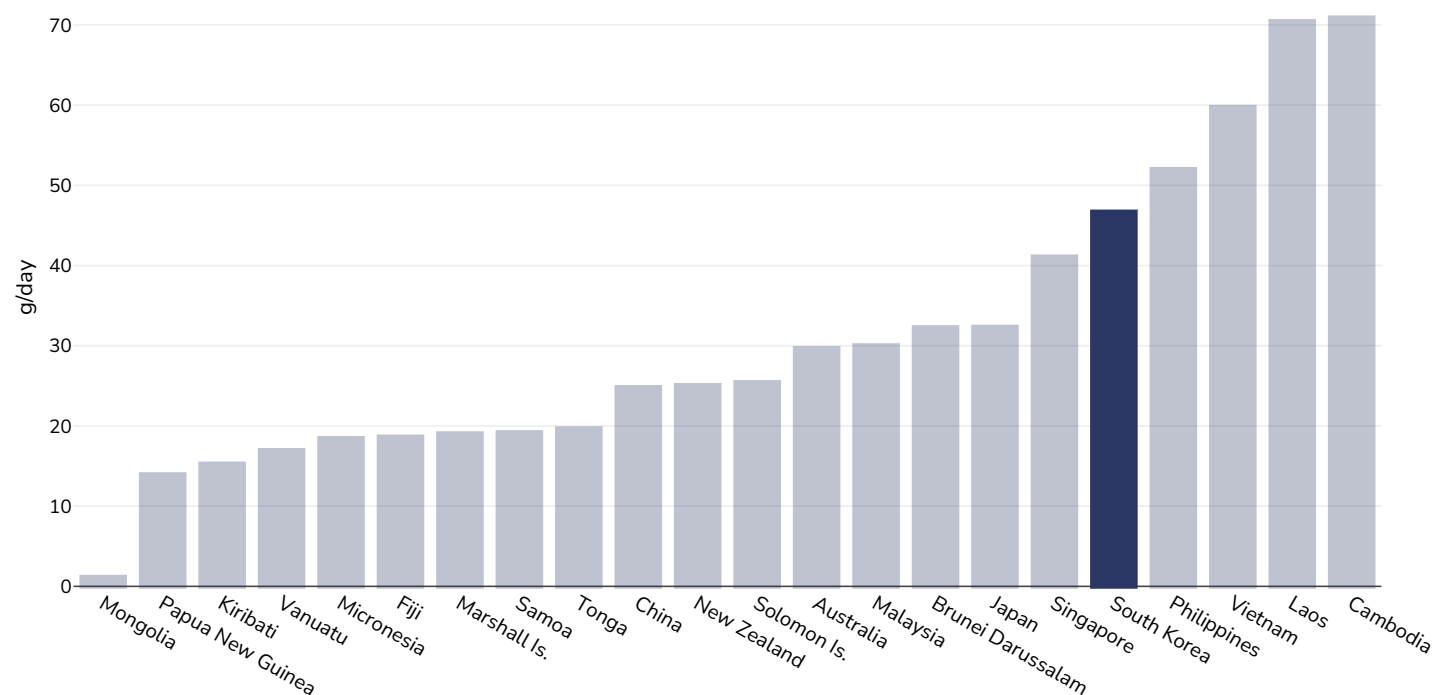

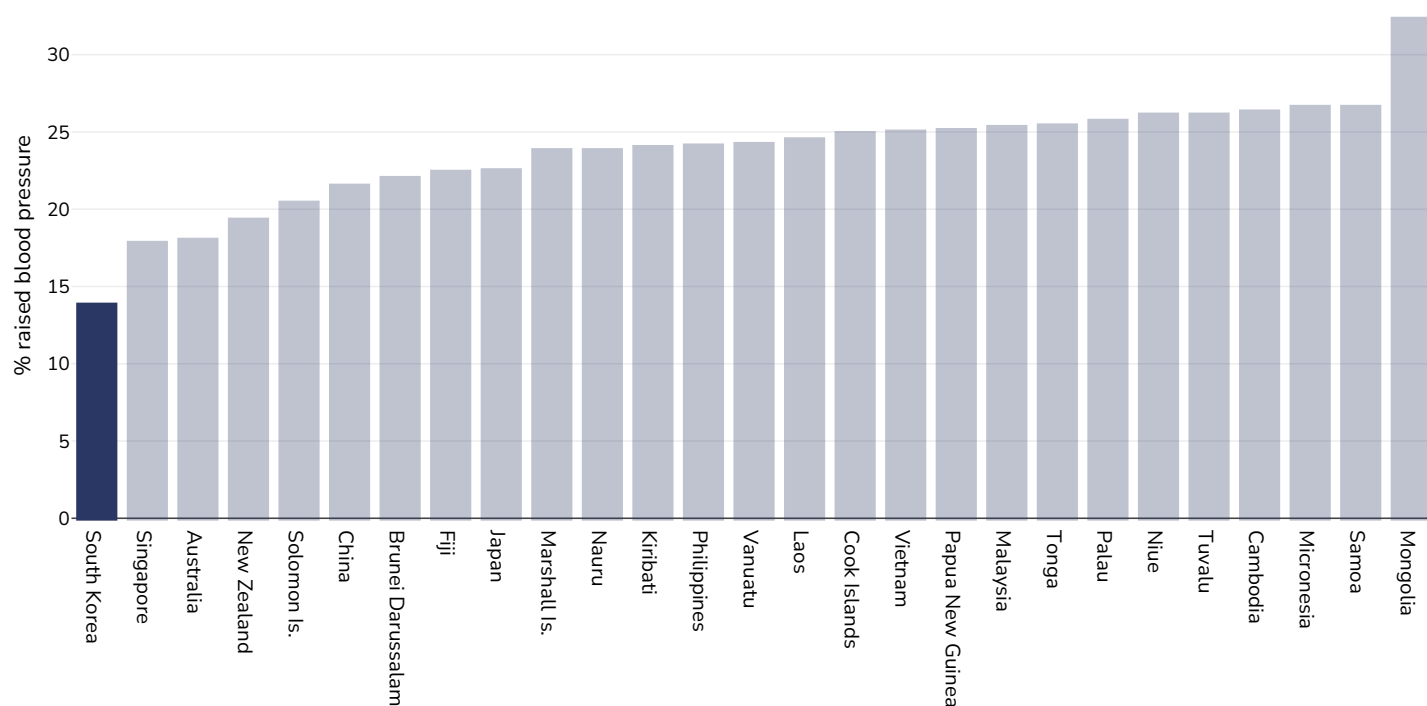

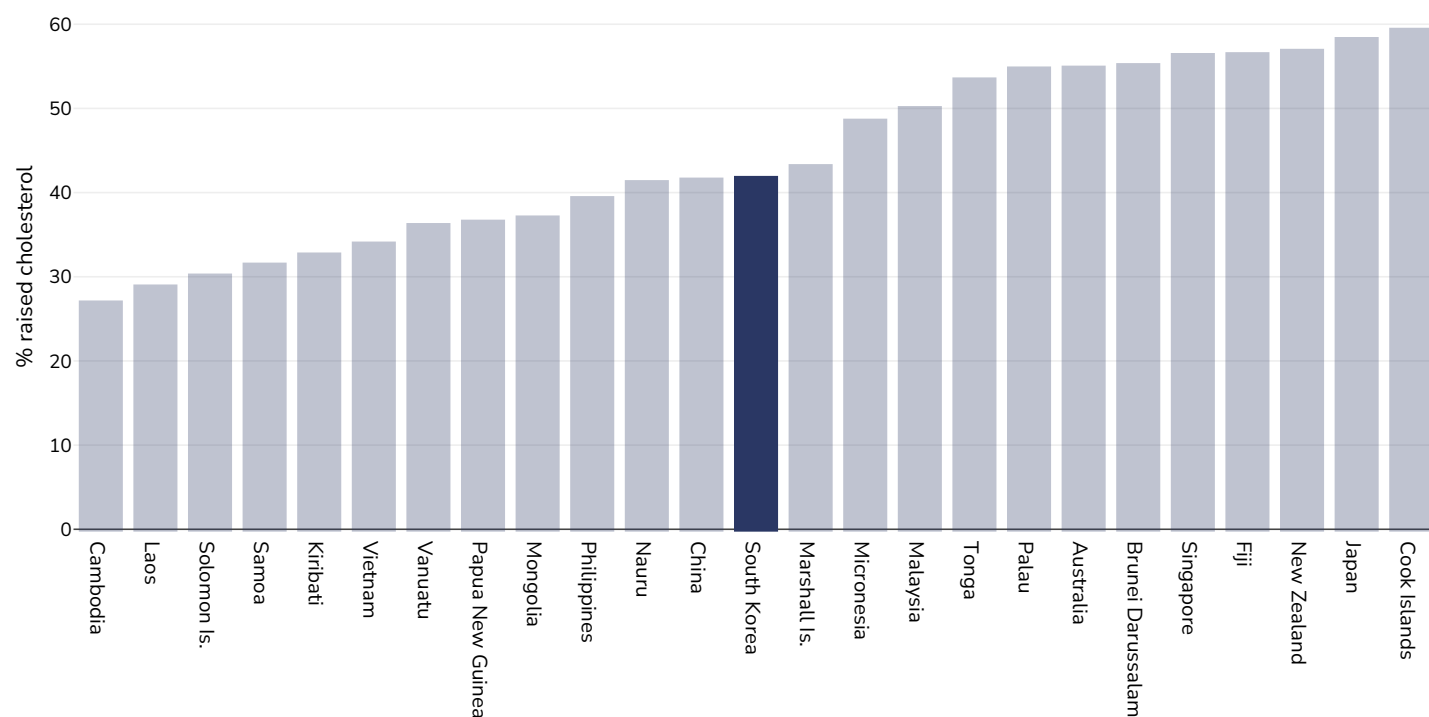

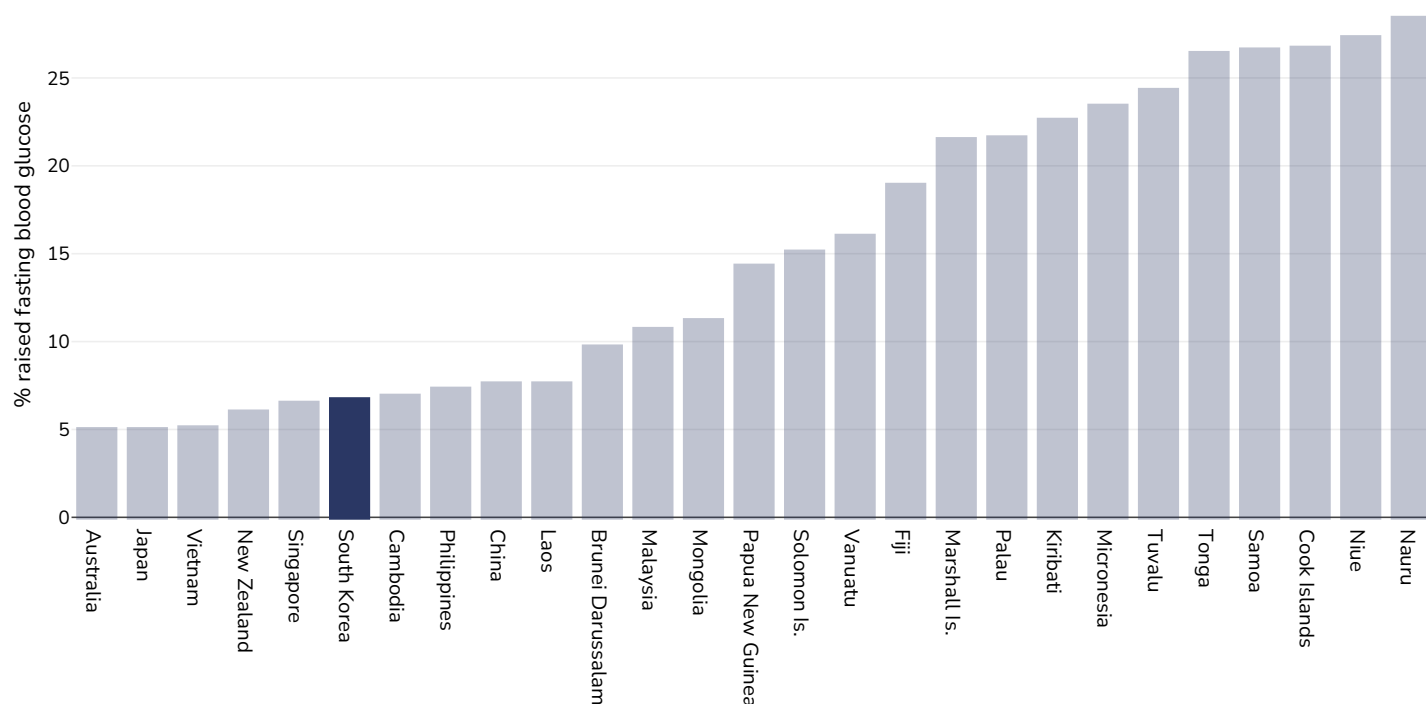

Raised fasting blood glucose

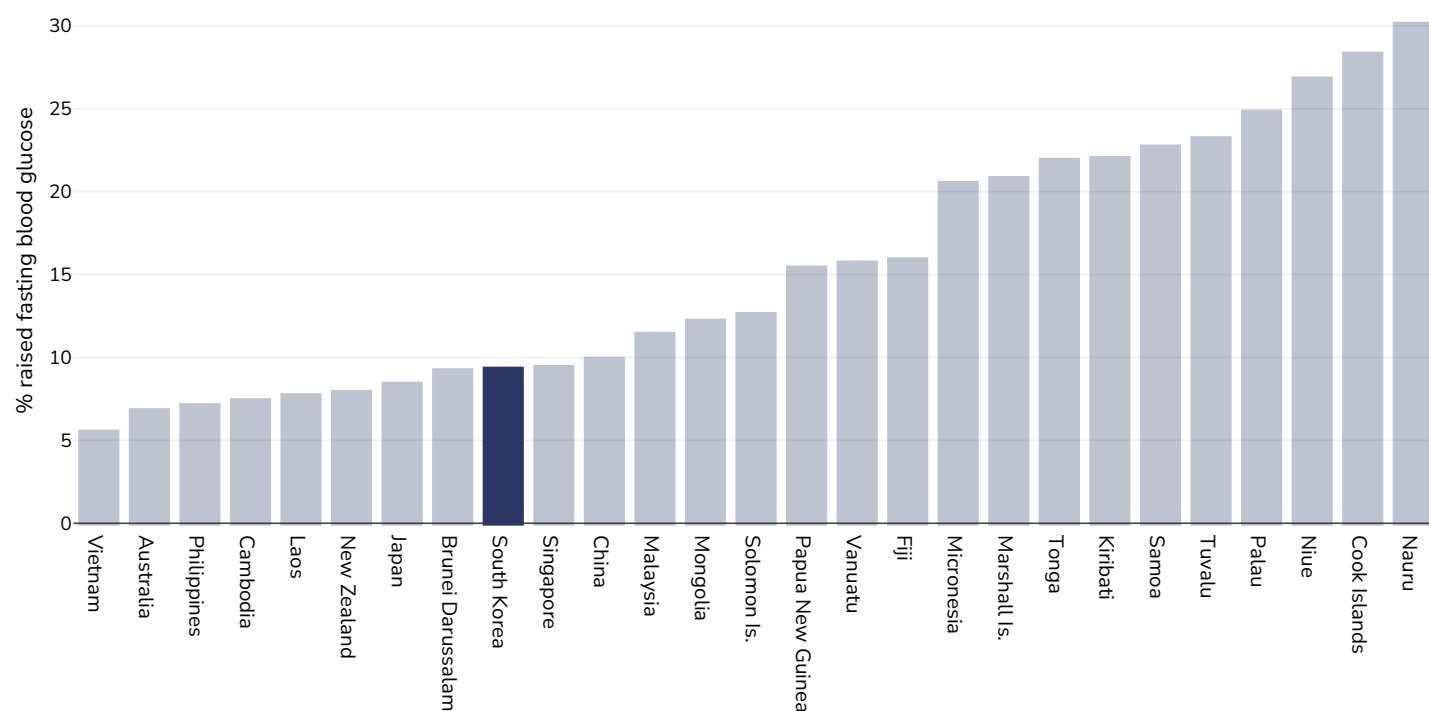

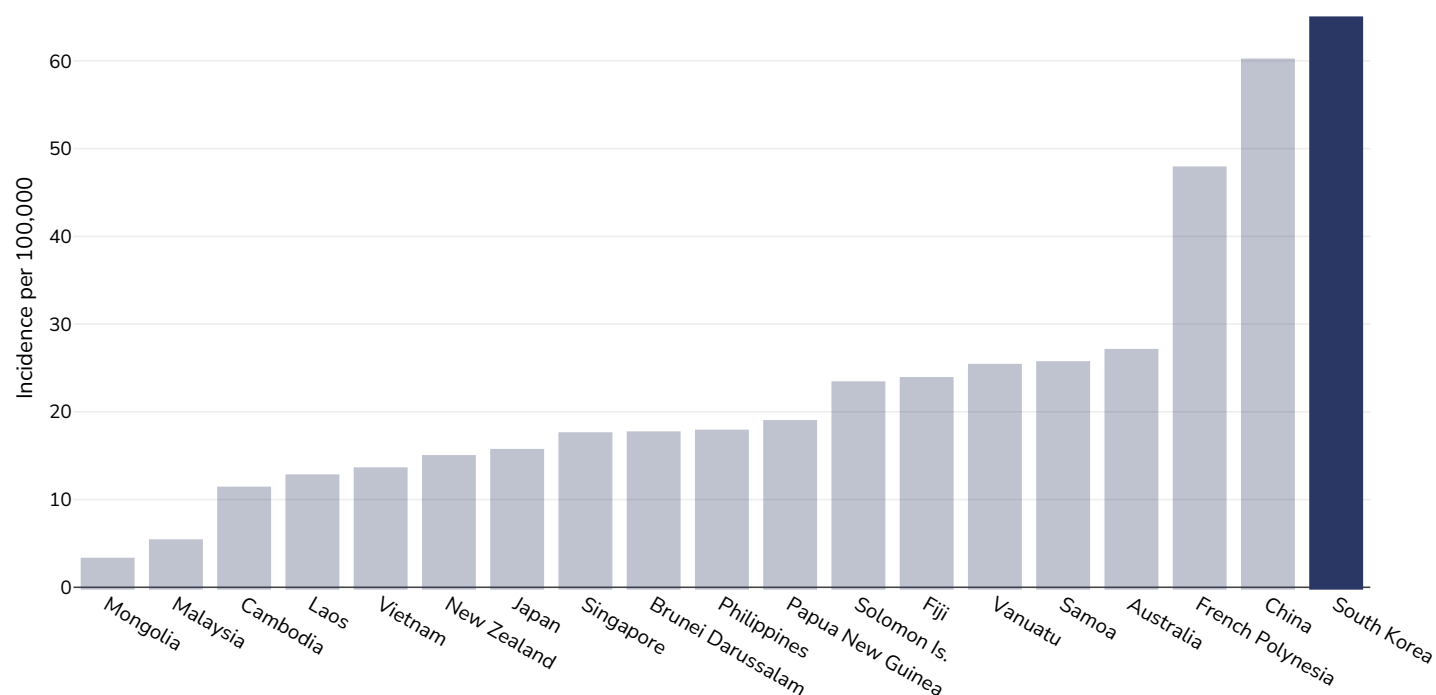
