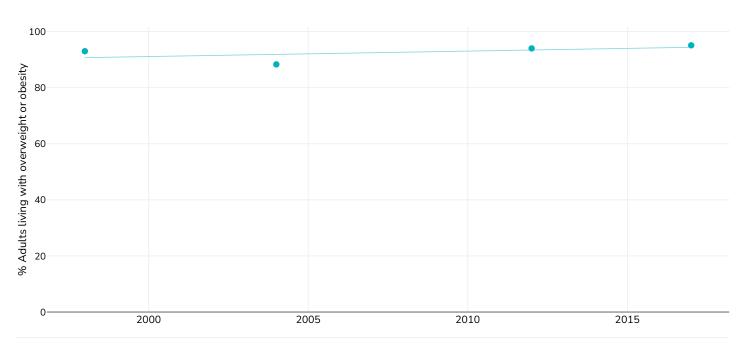

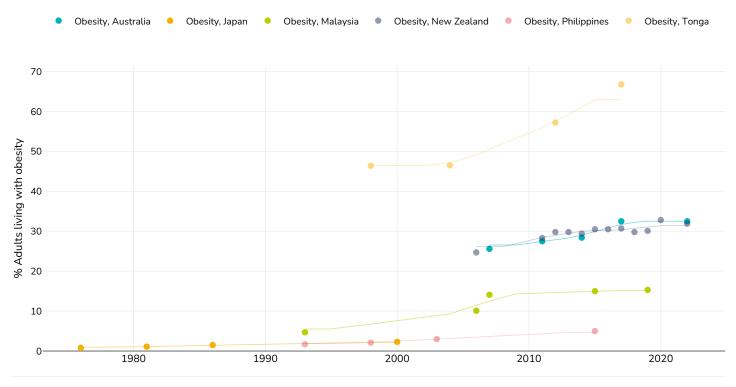

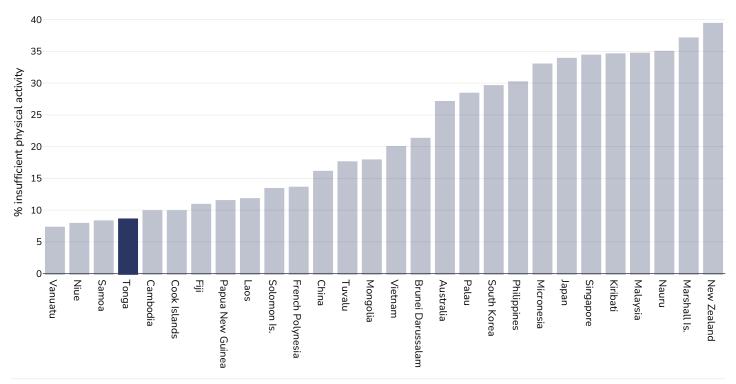

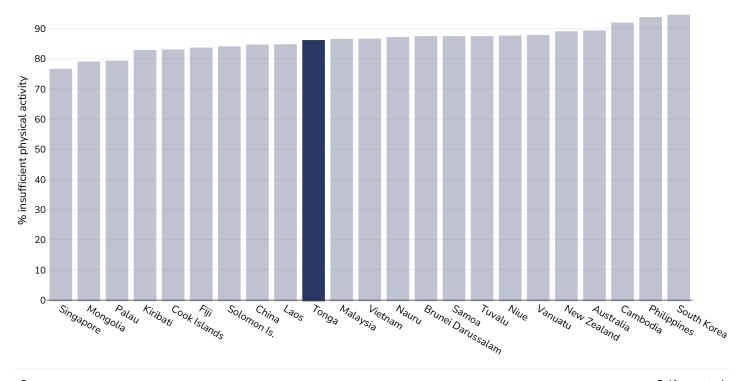

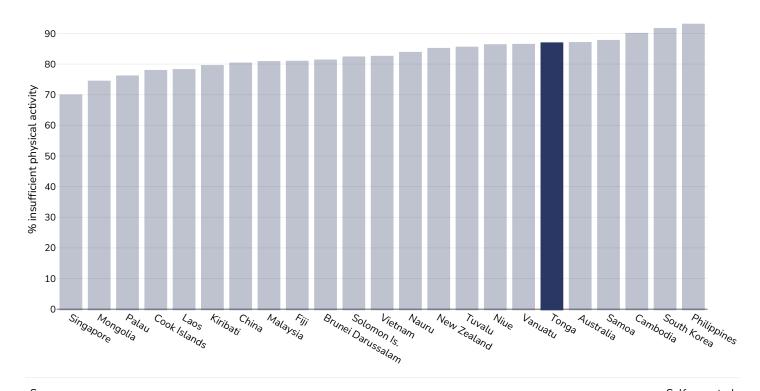

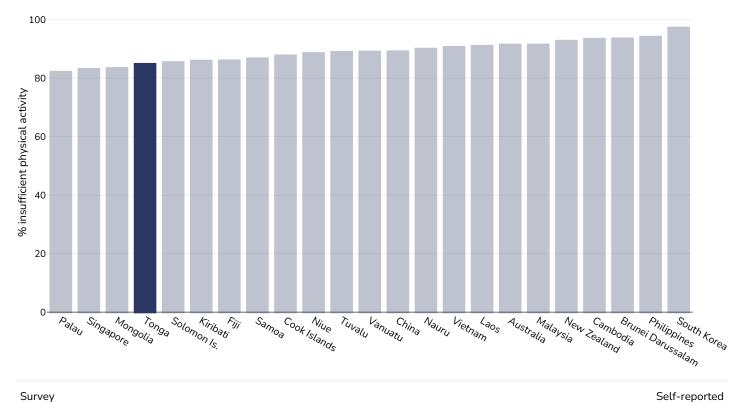

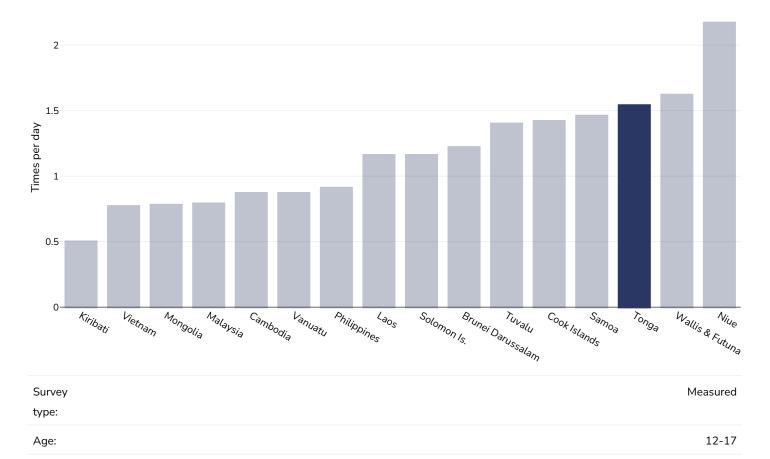

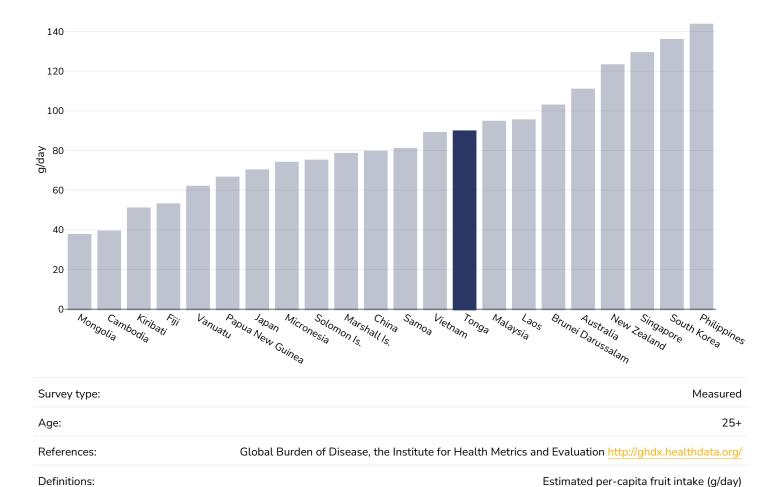

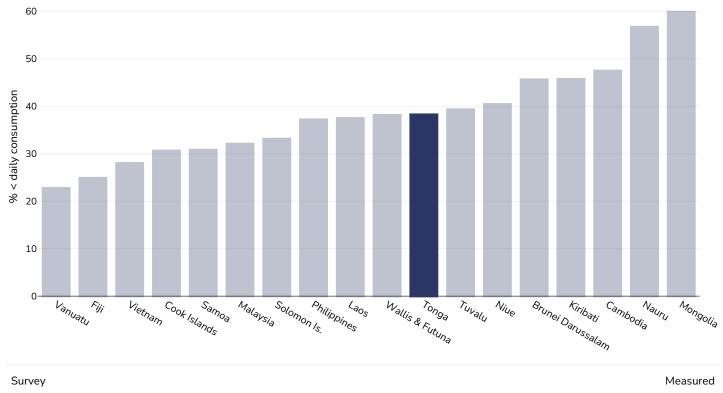




Prevalence of less than daily fruit consumption

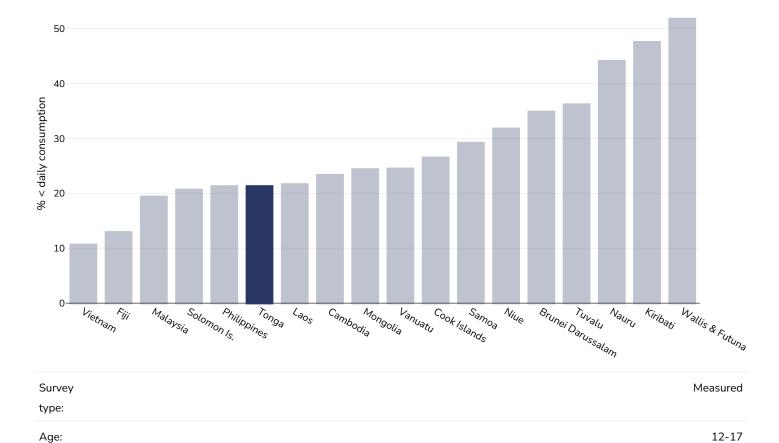

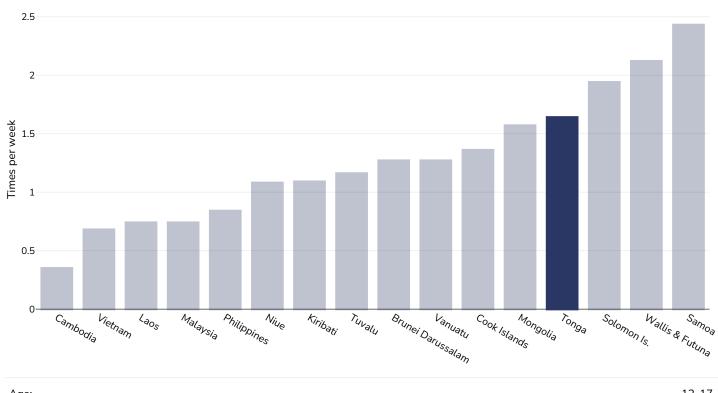

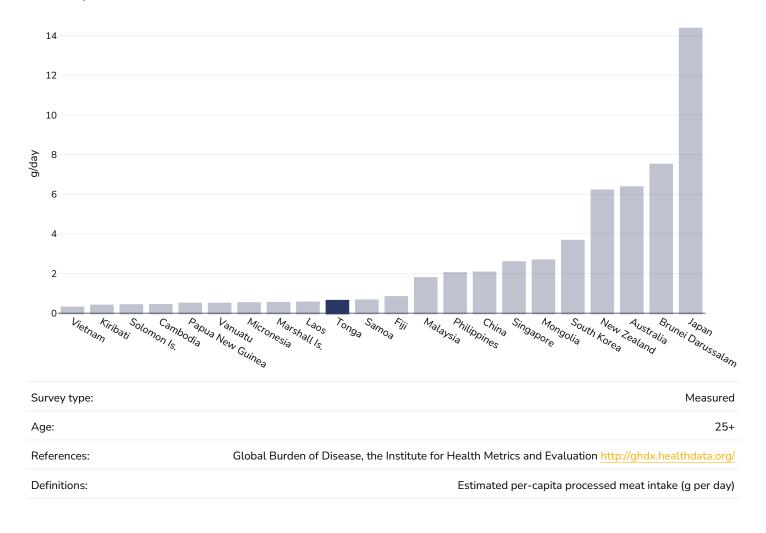

Estimated per-capita processed meat intake

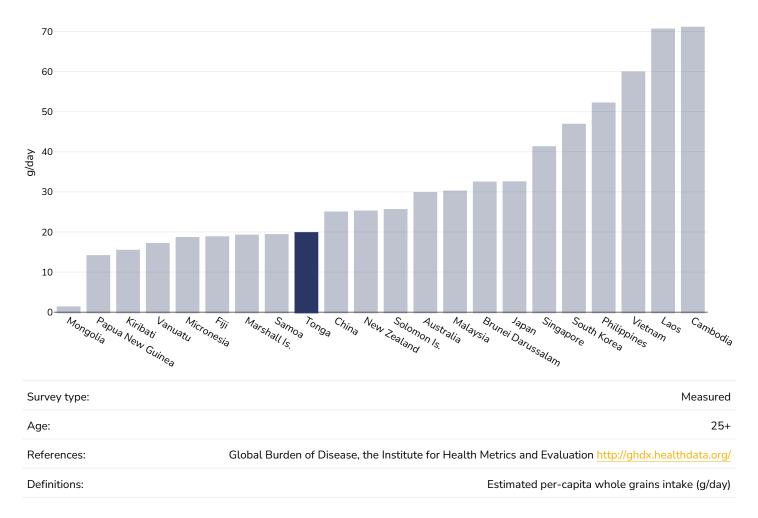

Estimated per capita whole grains intake

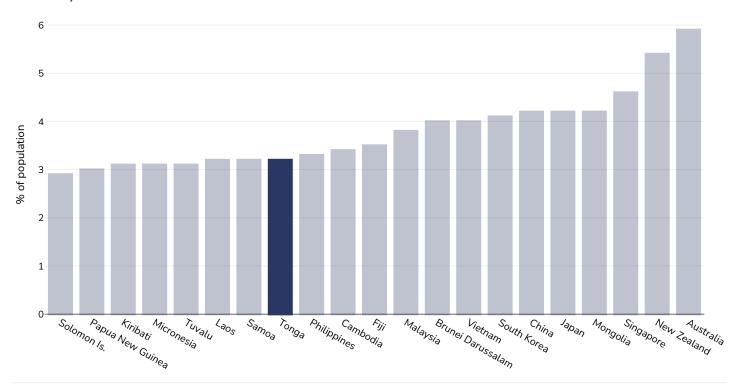

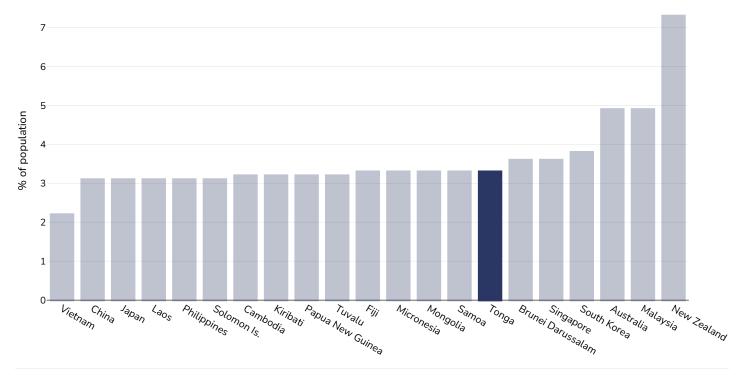

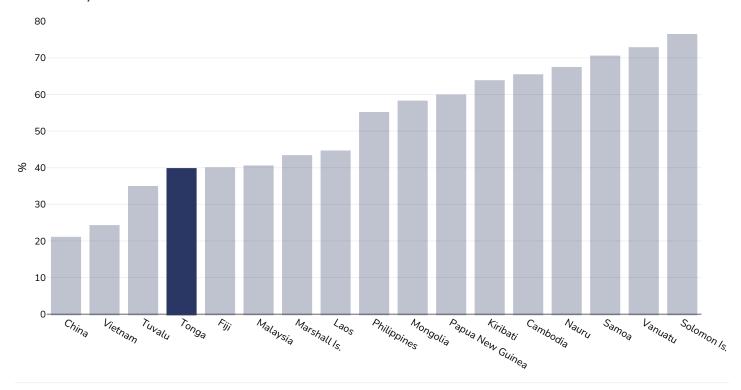

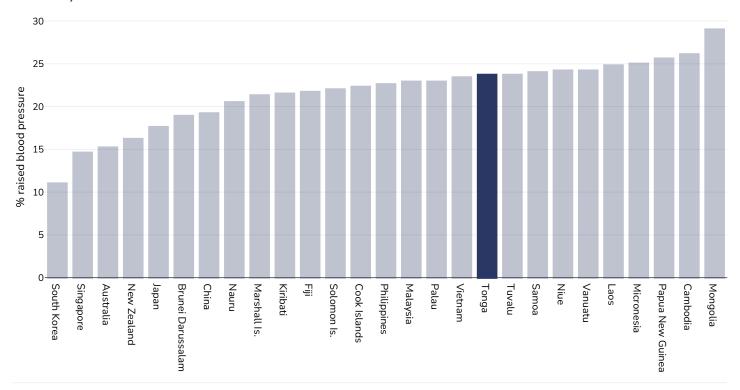

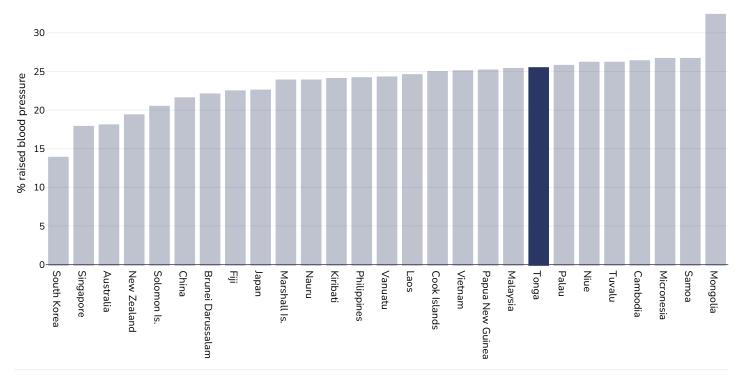

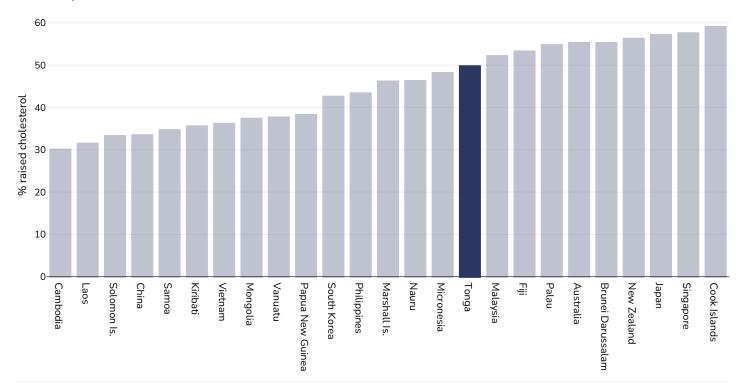

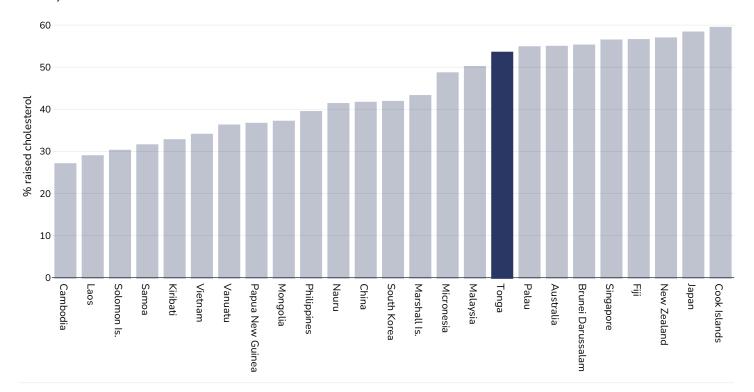

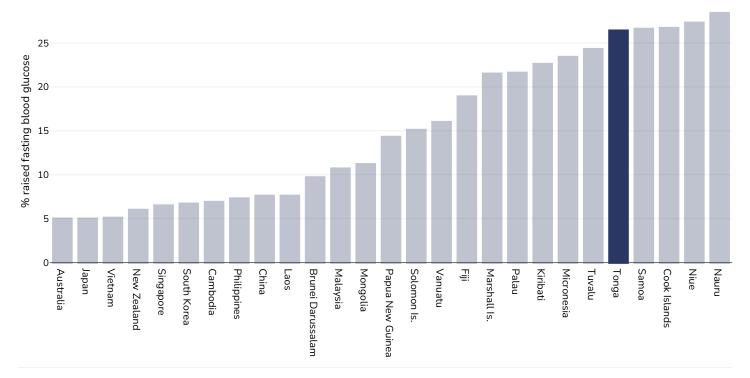

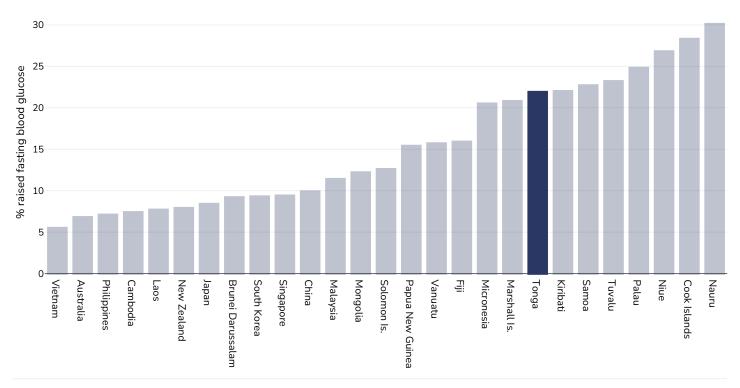

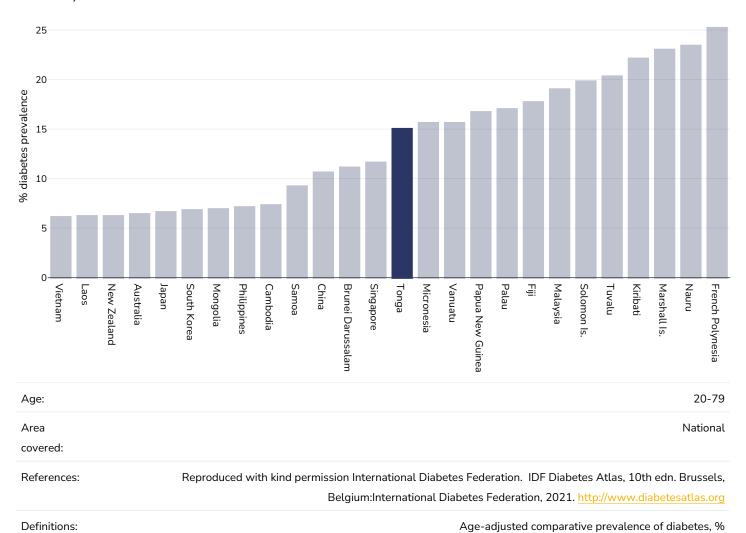
