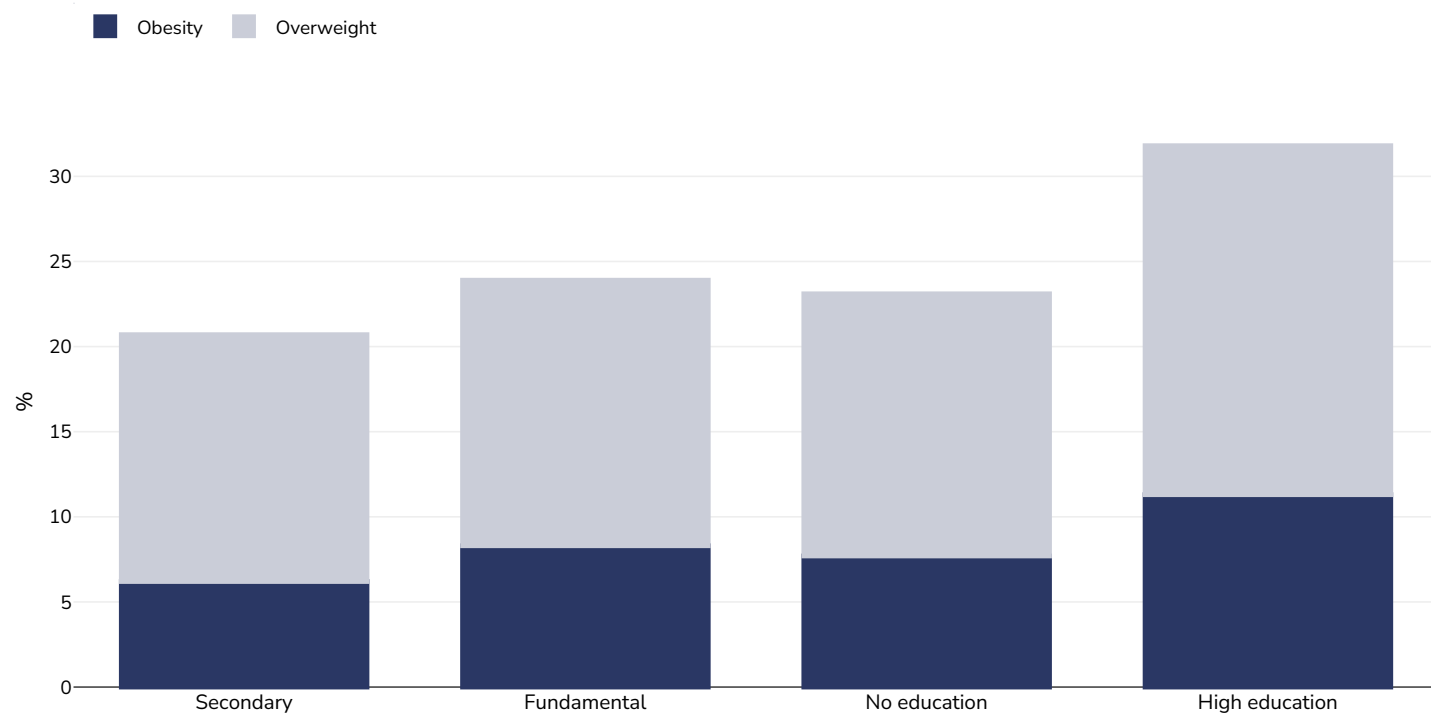

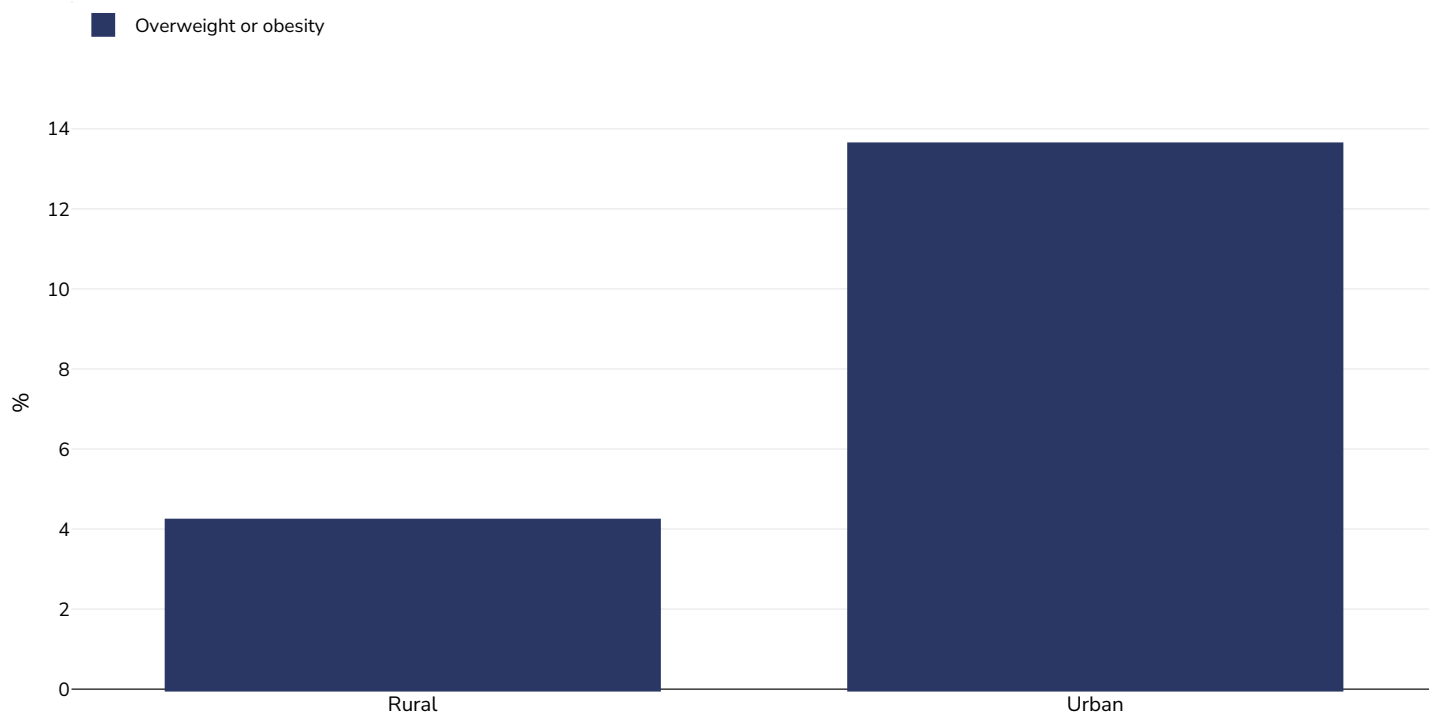

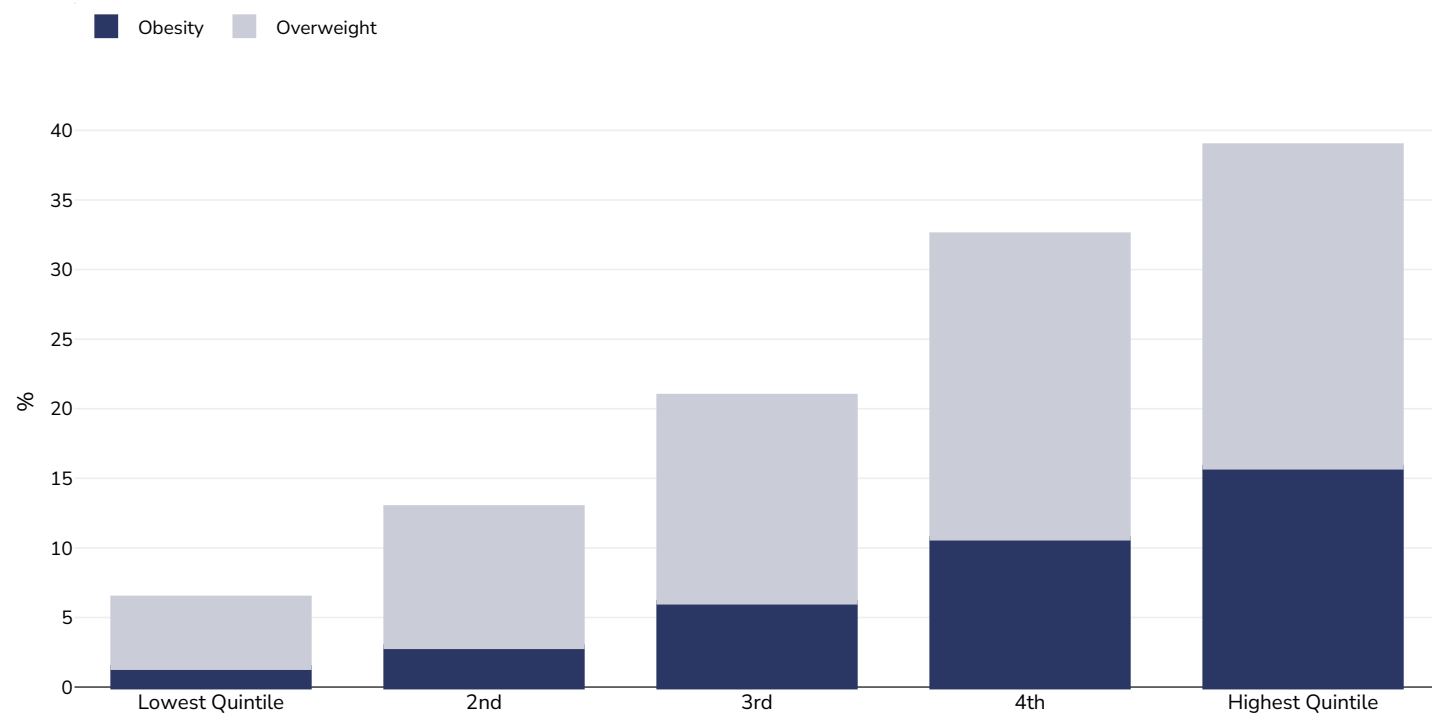

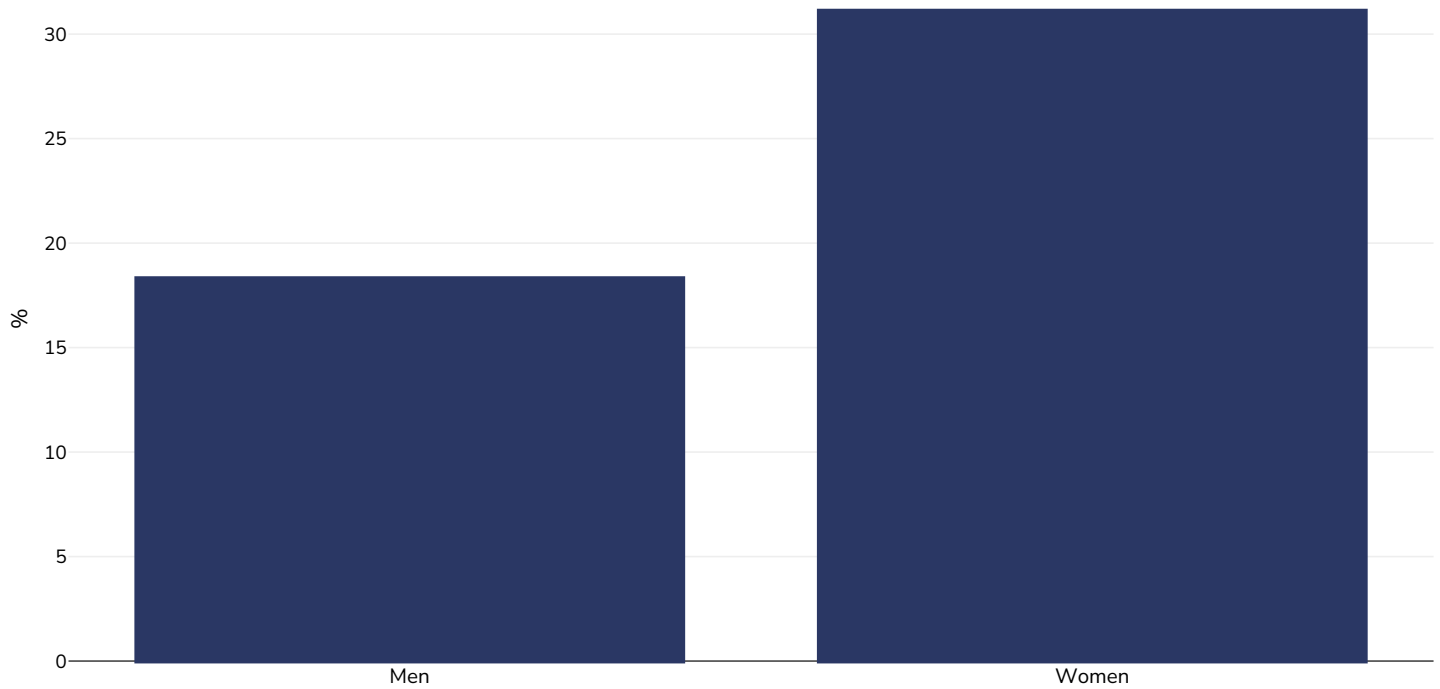

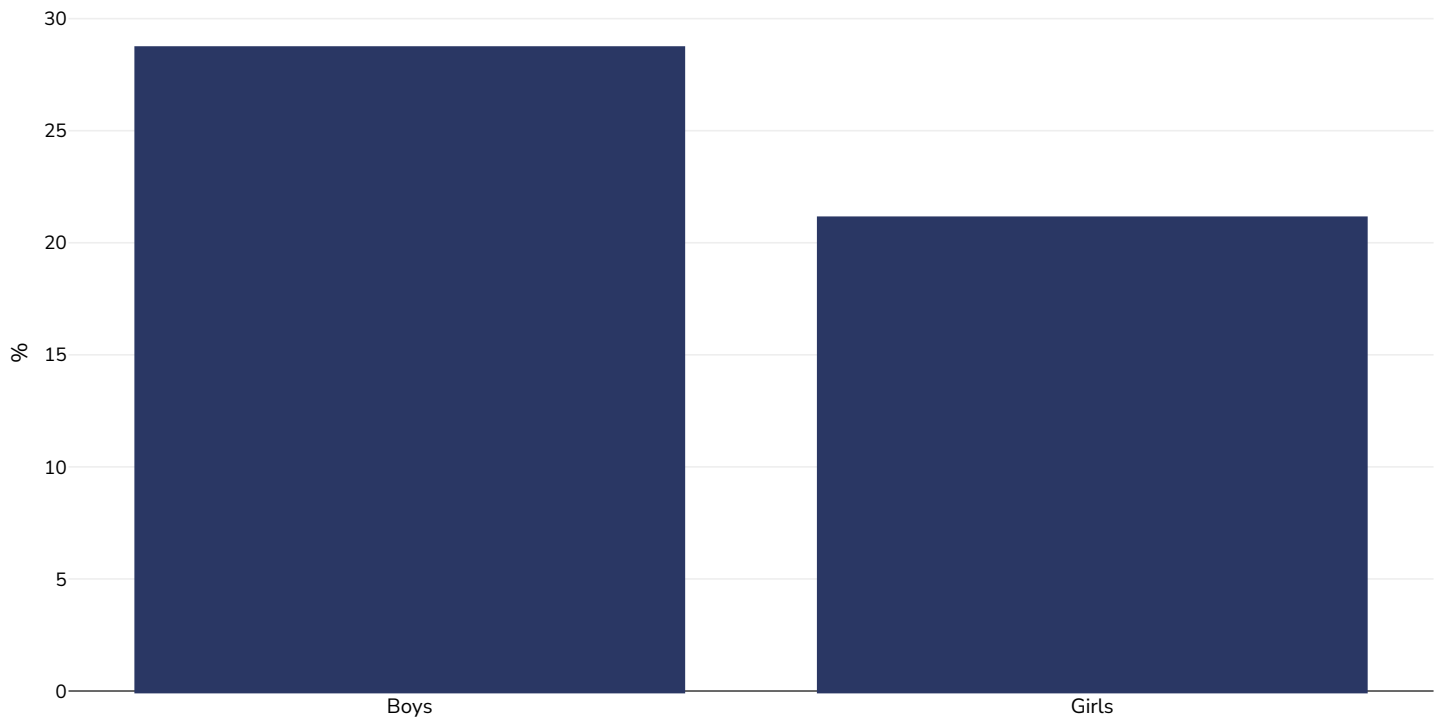

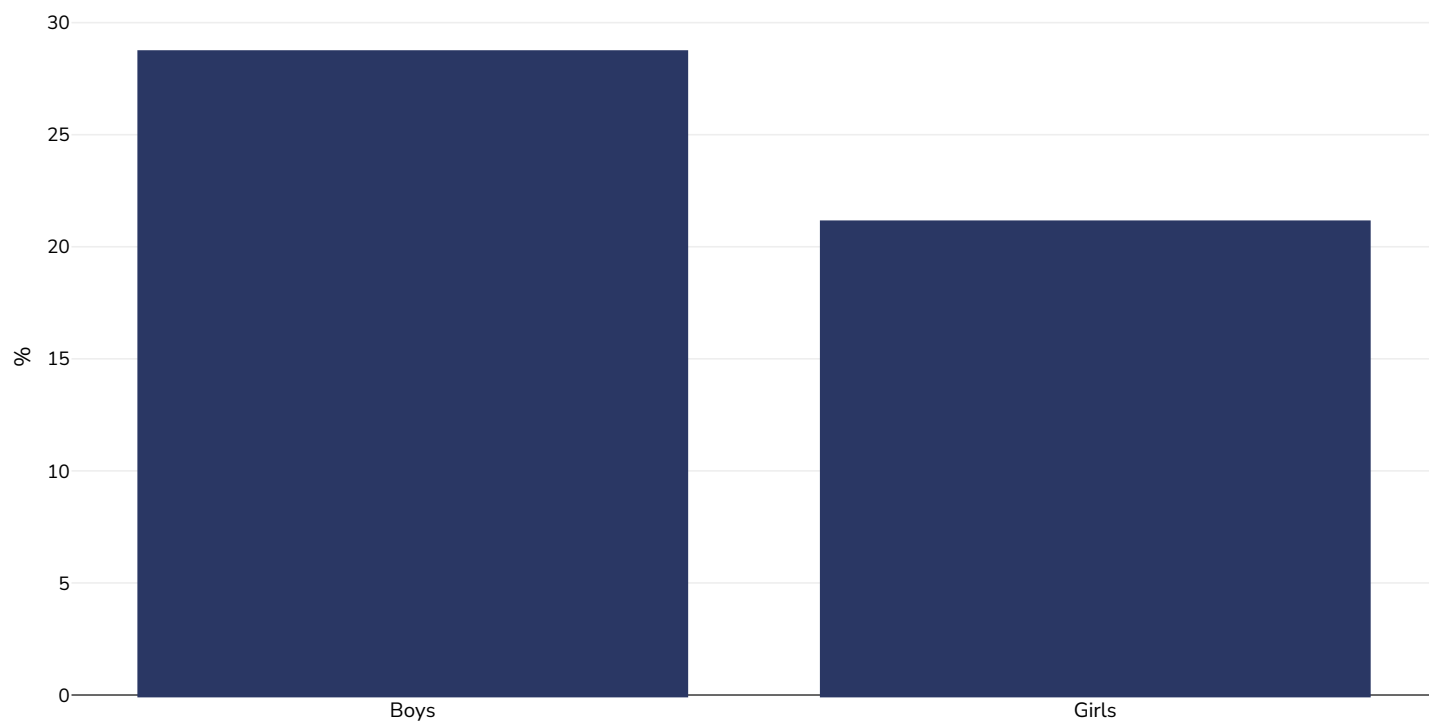

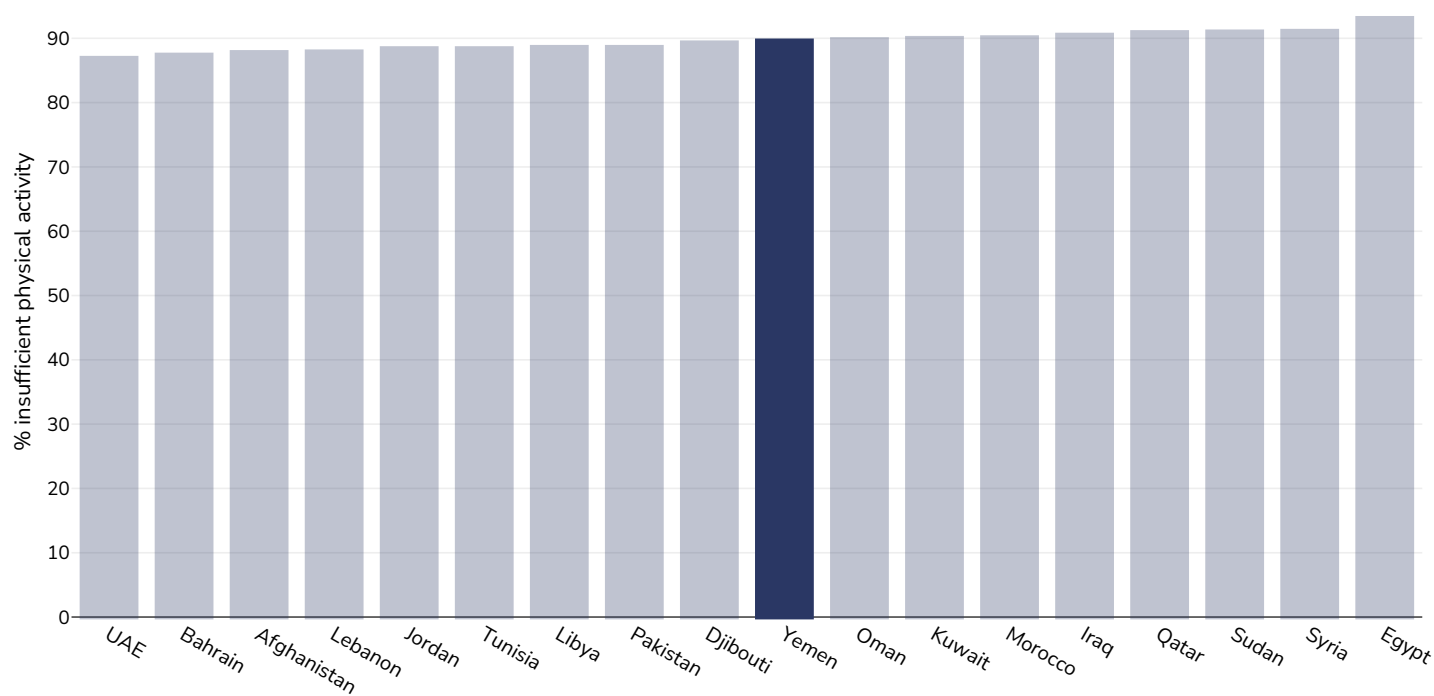

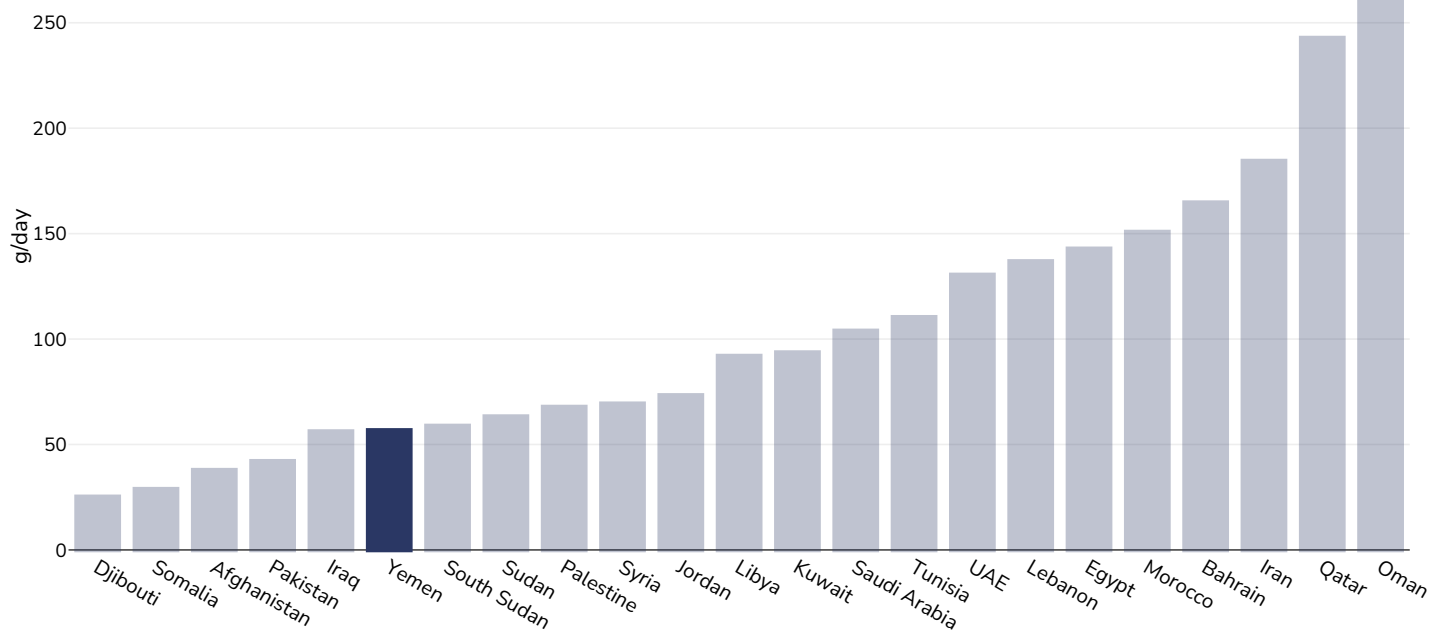

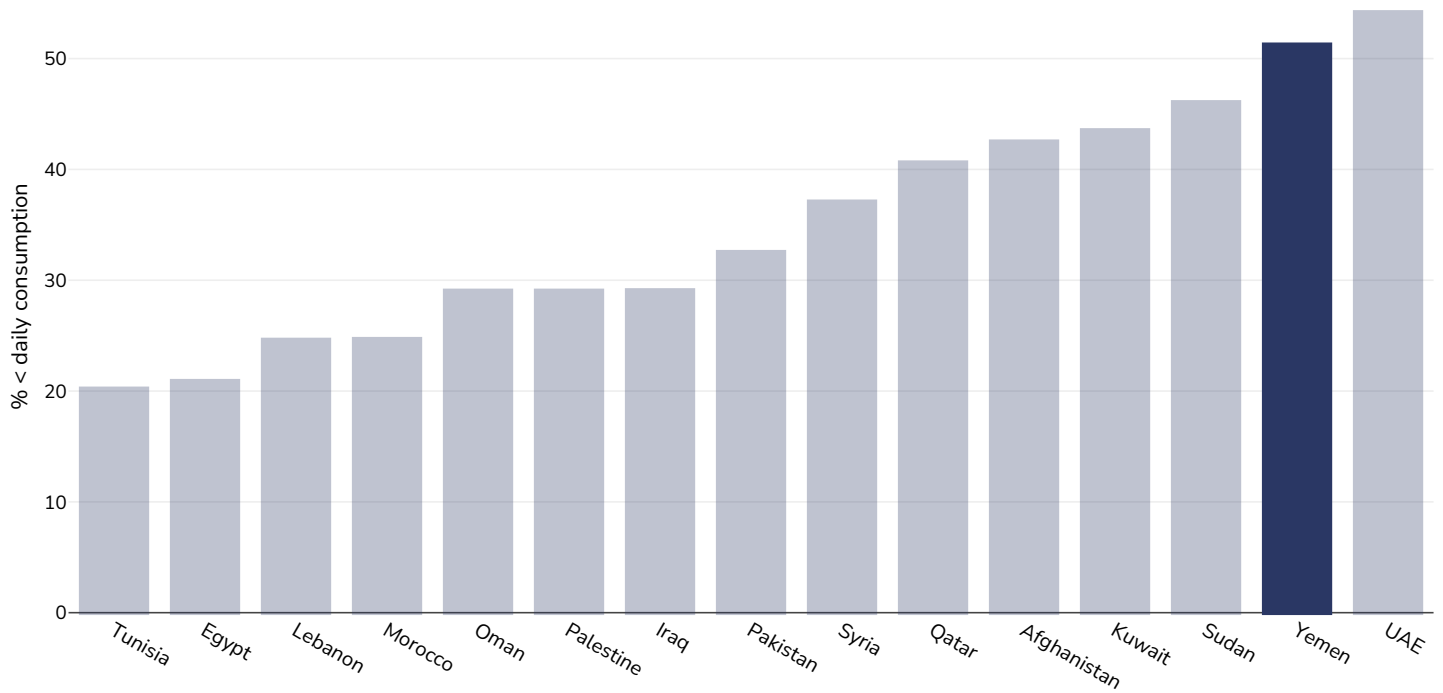

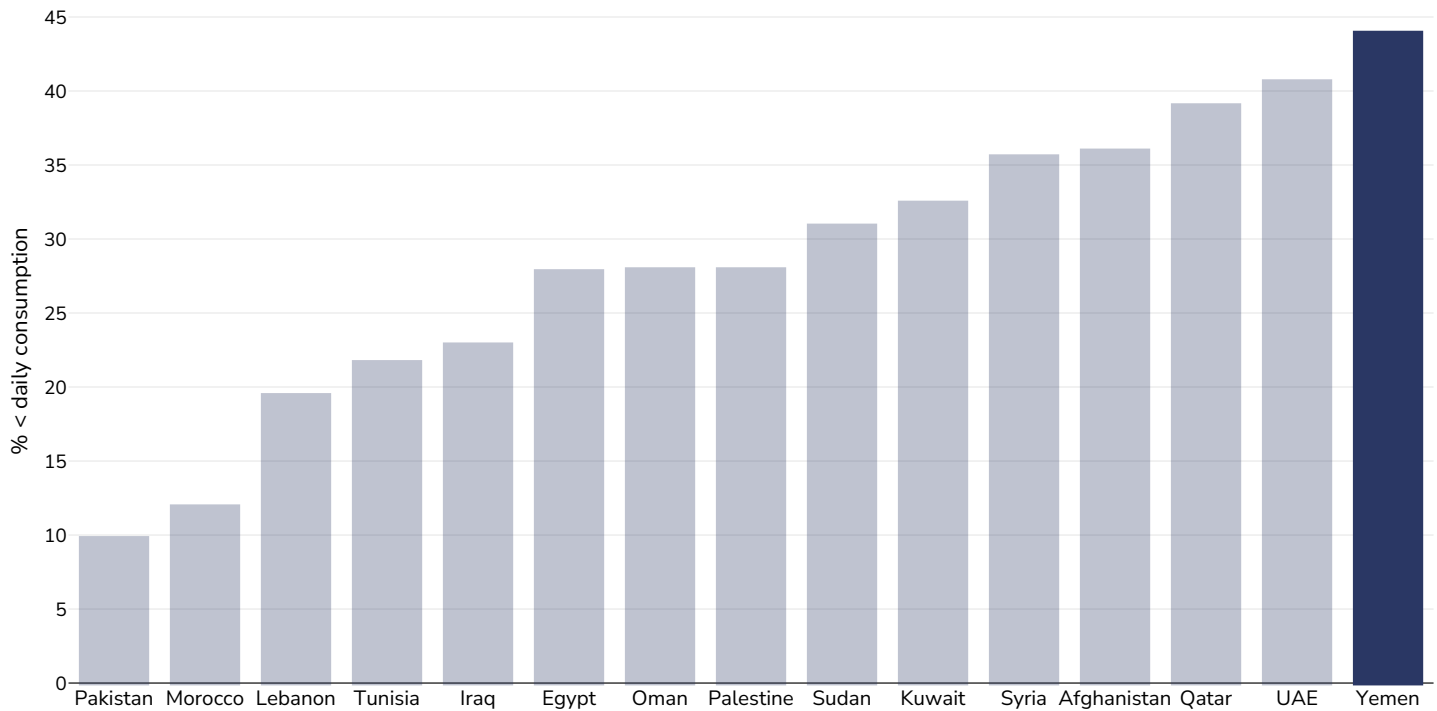

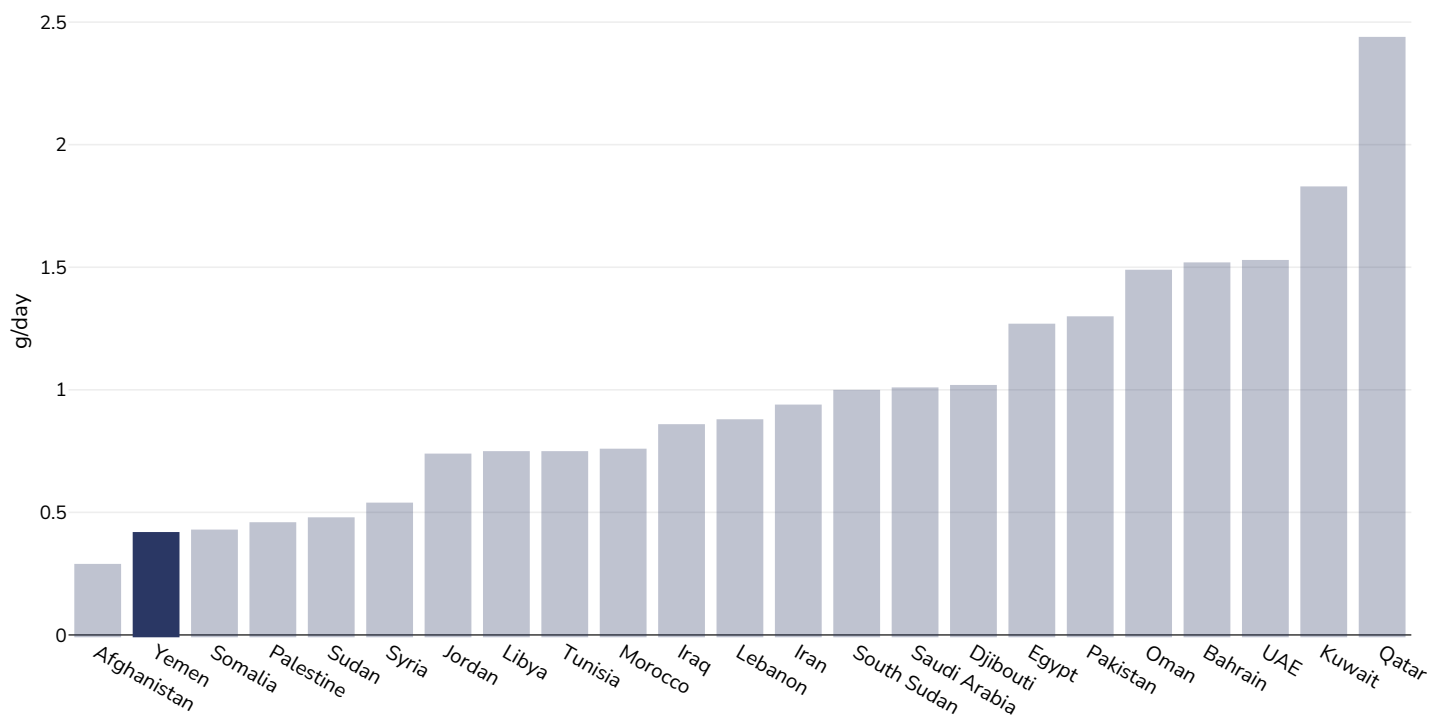

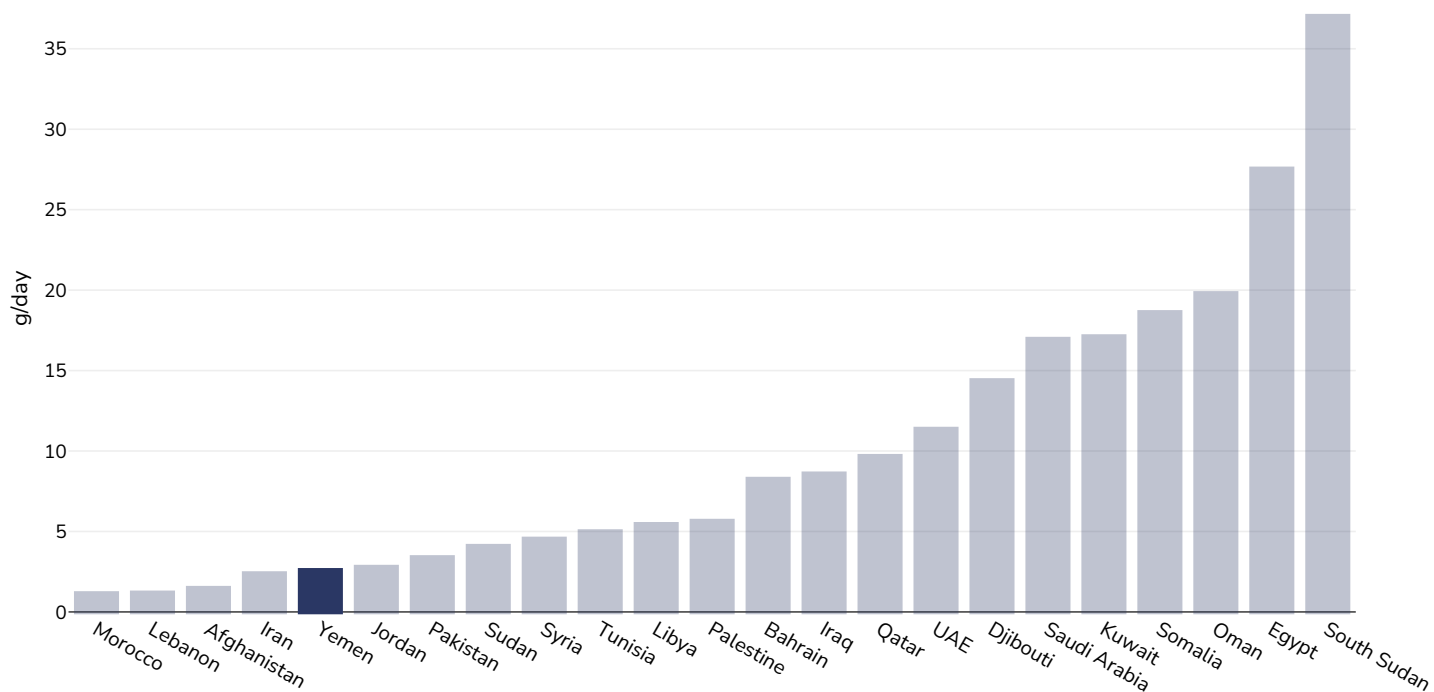

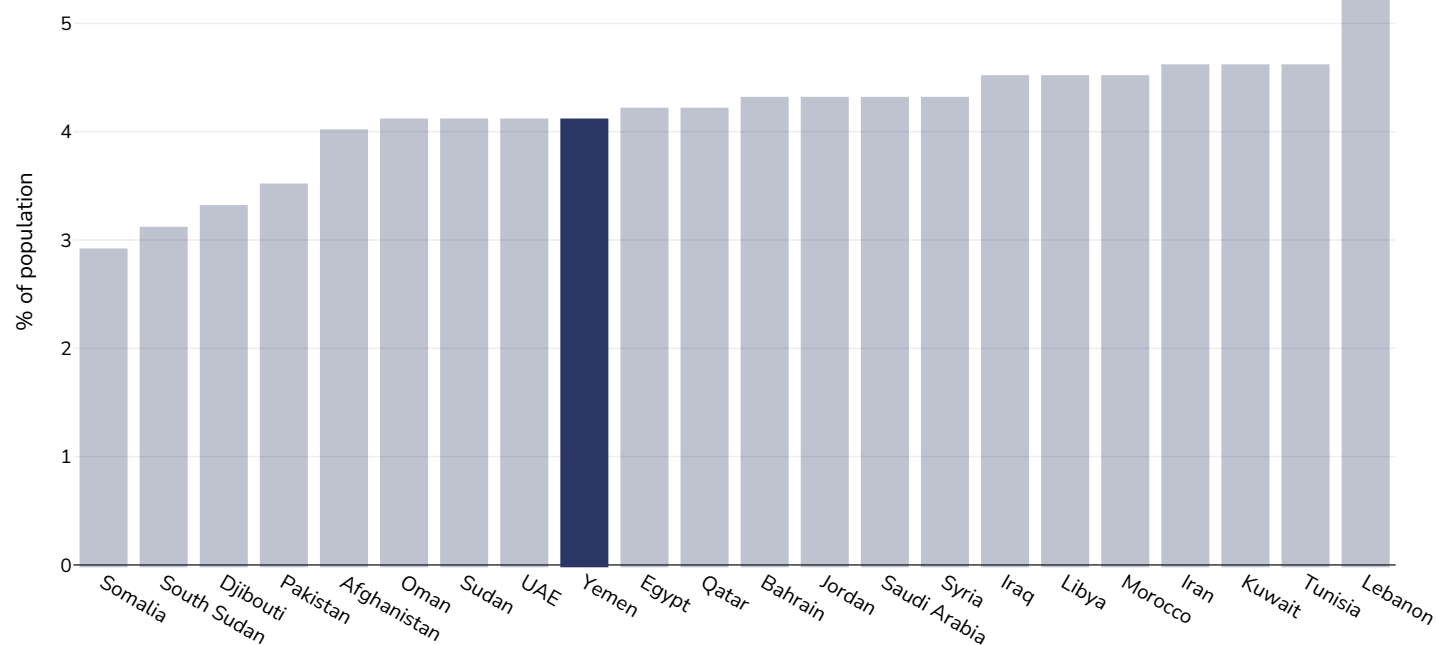

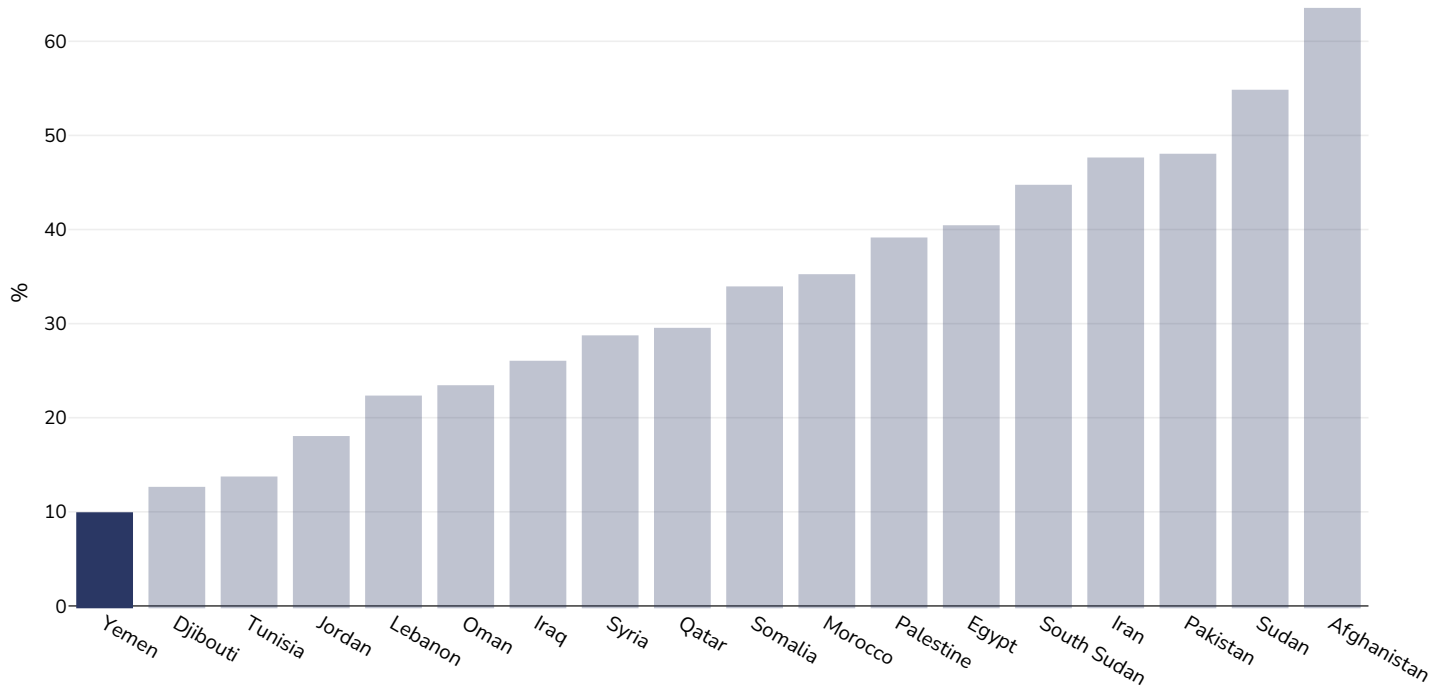

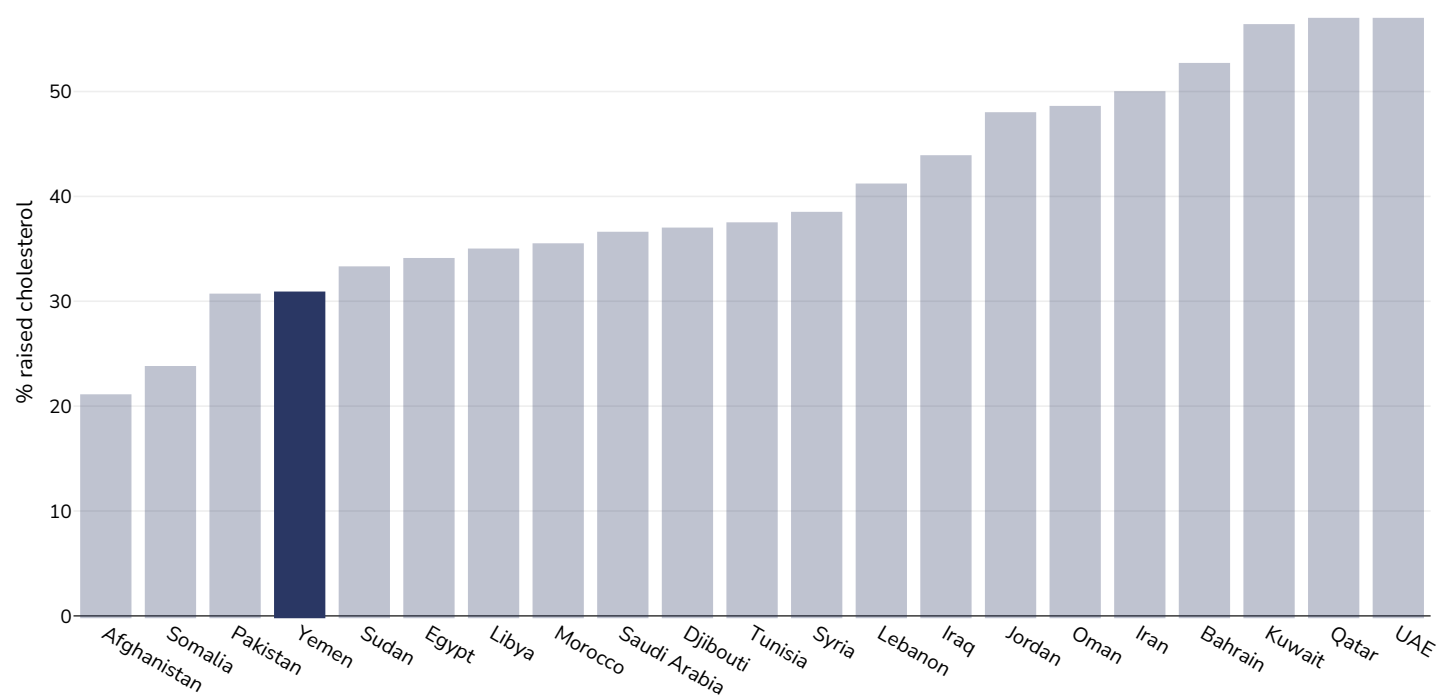

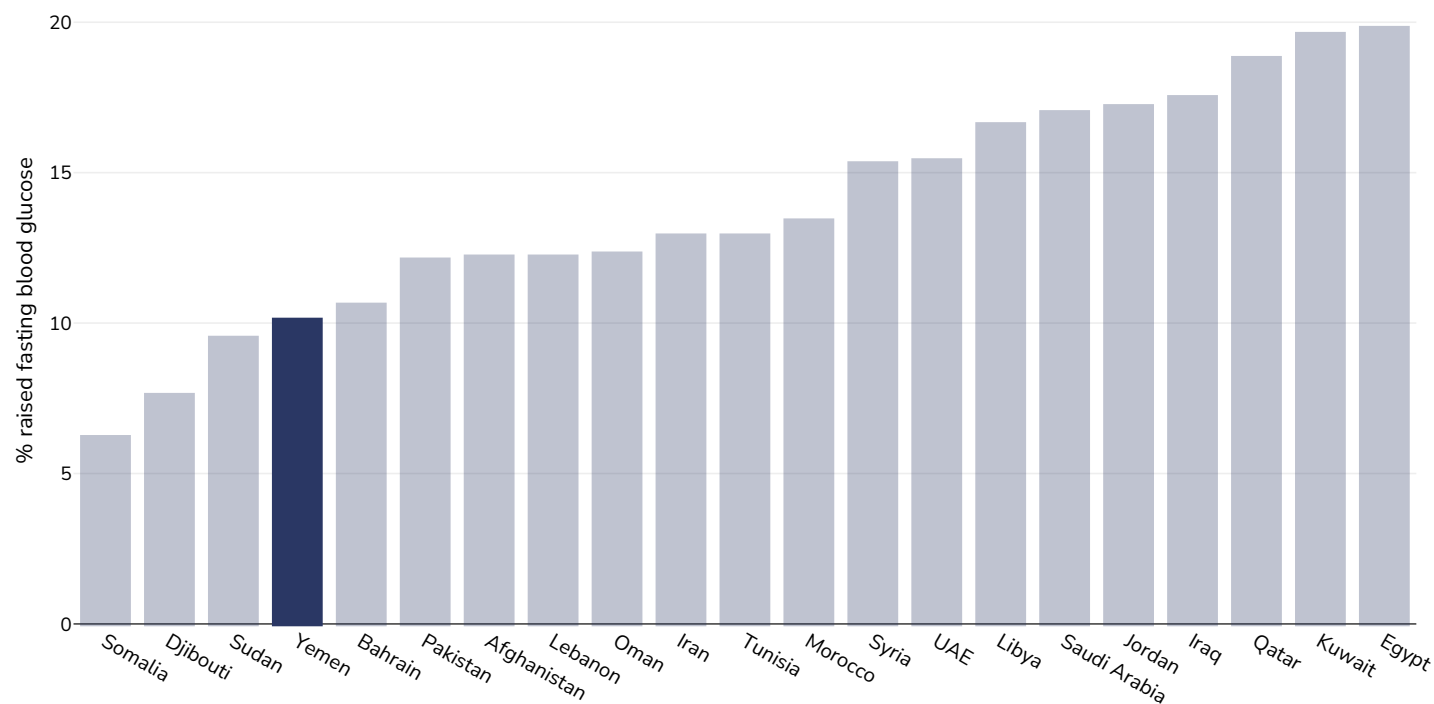

### Adults, 2024

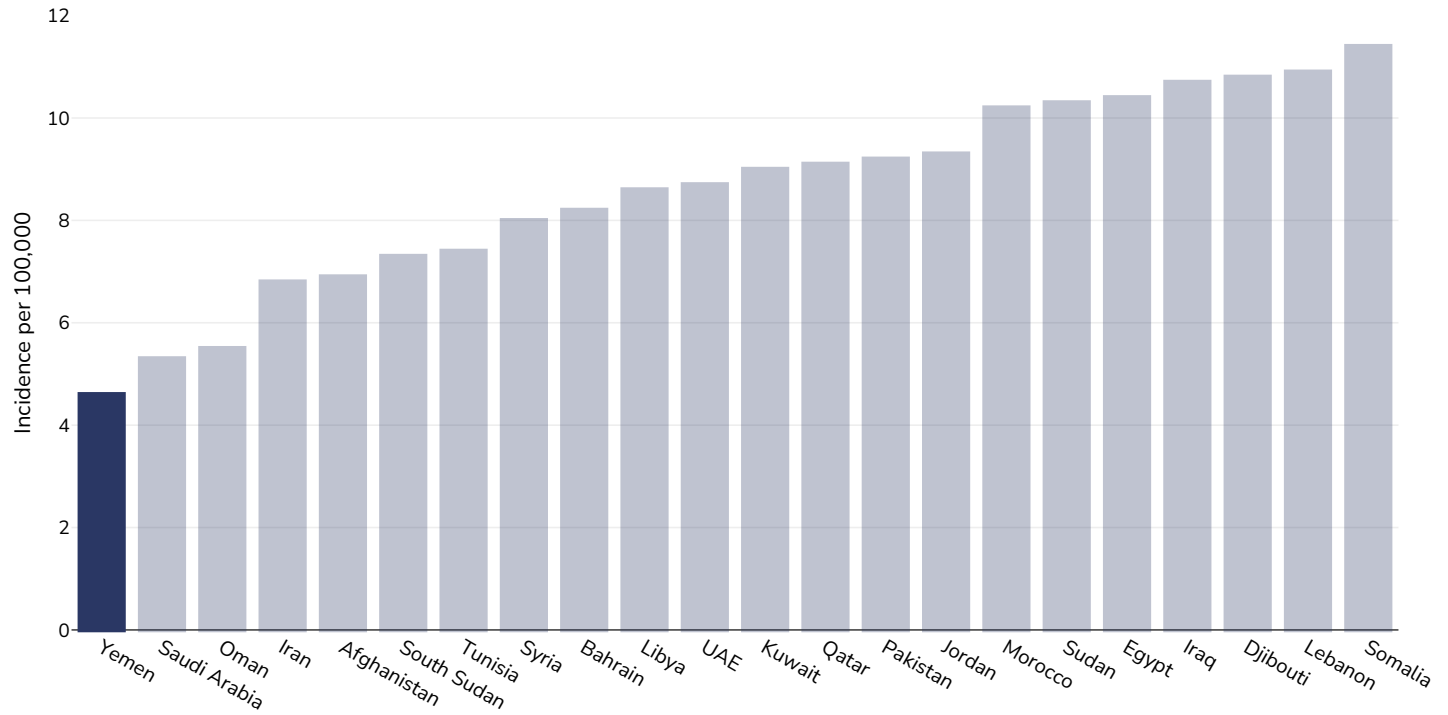
